SUBJECT: Mark-up, HR5499

Mark-up on HR 5499 will occur on Monday, June 9, 1980 within the Judiciary Subcommittee on Administrative Law and Governmental Relations. As stated in my memo of June 5, the subcommittee, in all likelihood, will amend the bill to conform with S. 1647.

Once mark-up occurs the bill will be reported to the Committee on the Judiciary for consideration.

Needless to say, it is important to gain as favorable a vote as possible within Judiciary. I would appreciate your efforts in eliciting your membership to first write letters to the members of the Judiciary Committee who have co-sponsored HR5499, thanking them for their support and reminding them of the importance of this issue. Secondly, I would appreciate letters to those members of Judiciary who have not as yet co-sponsored HR5499, urging their support and favorable consideration of the legislation.

Your efforts to date are truly appreciated. As mentioned previously, our efforts cannot be relaxed inasmuch as after Judiciary consideration, we must then contend with the full House.
