Thank you for your letter in which you express your support for H.R. 5499, the Commission on Wartime Relocation and Internment of Civilians Act.

As you know, this legislation has been approved by the House Judiciary Committee, and further consideration in the full House of Representatives is scheduled for July 21. I supported a bill passed in the last Congress (now Public Law 95-382) to provide Federal employee retirement credit to those Japanese-American employees who spent time during World War II in internment camps, and when H.R. 5499 comes to the House Floor for action, you may be assured that I shall bear your views on this public issue in mind.

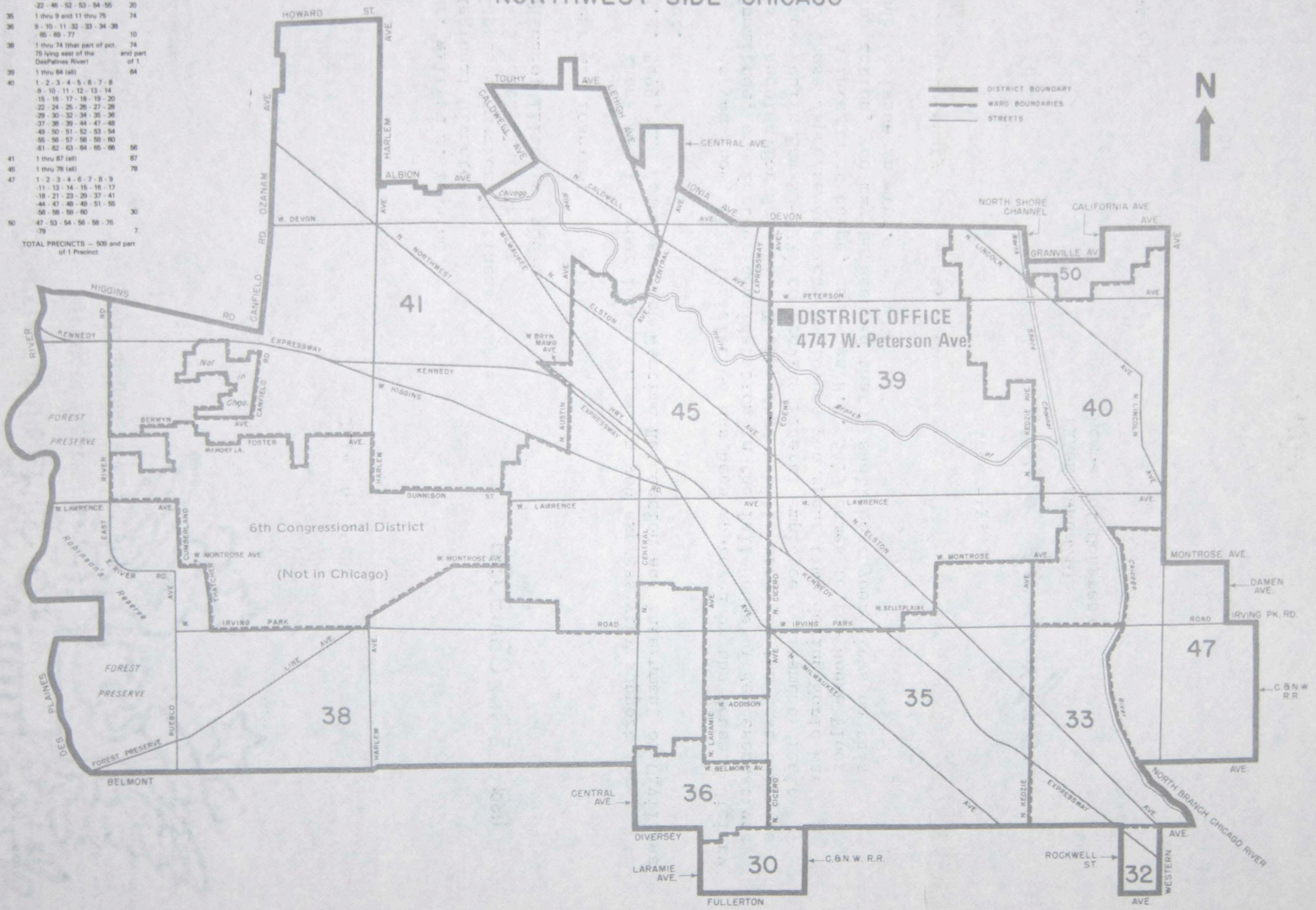
