16 Be it enacted by the Senate and House of Representatives of the United States
17 of America in Congress assembled.

Short title

21 Section 1. This Act may be cited as the "Commission on Wartime Relocation and
22 Internment of Civilians Act".
23

Findings and purpose

24
25
26 Sec. 2. (a) The Congress finds that --

27 (1) ~~Approximately~~ approximately one hundred and twenty thousand civilians
28 were relocated and detained in internment camps pursuant to Executive Order
29 Numbered No. 9066, dated issued February 19, 1942, and other associated ~~acts~~
30 actions of the Federal Government; and

31 (2) no sufficient inquiry into this matter has been made.

32 (b) It is the purpose of this Act to establish a ~~factfinding-commission-to~~
33 ~~determine-whether-a-wrong-was-committed-against-these-American-citizens-and~~
34 ~~permanent-resident-aliens-relocated-and/or-interned-as-a-result-of-Executive~~
35 ~~Order-Numbered-9066-and-other-associated-acts-of-the-Federal-Government,~~
36 establish a commission to review the facts and circumstances surrounding
37 Executive Order No. 9066, issued February 19, 1942, and the impact of such
38 Executive Order on American citizens and permanent resident aliens, and
39 to recommend appropriate remedies.

Establishment of commission

43 Sec. 3. (a) There is established the Commission on Wartime Relocation and
44 Internment of Civilians (hereinafter referred to as the "Commission").

45 (b) The Commission shall be composed of ~~fifteen~~ seven members, who shall be
46 appointed as follows:

47 (1) ~~Eleven~~ Three members shall be appointed by the President.

48 (2) Two members ~~of-the-House-of-Representatives~~ shall be appointed by
49 the Speaker of the House of Representatives

1 (3) Two ~~Member-of-the-Senate~~ members shall be appointed by the President
2 pro tempore of the Senate.

3 (c) The term of office for members shall be for the life of the Commission.
4 A vacancy in the Commission shall not affect its powers, and shall be filled in
5 the same manner in which the original appointment was made.

6 (d) The first meeting of the Commission shall be called by the President
7 within sixty days following after the date of enactment of this Act.

8 (e) ~~Eight~~ Four members of the Commission shall constitute a quorum, but
9 a lesser number may hold hearings.

10 (f) The Commission shall elect a Chairman and Vice Chairman from among its
11 members. The term of office of each shall be for the life of the Commission.

12 (g) Each member of the Commission who is not otherwise employed by the
13 United States Government shall receive compensation at a rate equal to the
14 daily rate prescribed for GS-18 under the General Schedule contained in Section
15 5332 of title 5, United States Code, ~~including-traveltime~~, for each day-day,
16 including traveltime, he or she is engaged in the actual performance of his
17 or her duties as a member of the Commission. A member of the Commission who
18 is an officer or employee of the United States Government shall serve without
19 additional compensation. All members of the Commission shall be reimbursed
20 for travel, subsistence, and other necessary expenses incurred by them in
21 the performance of their duties.

22 Duties of the commission

25 Sec. 4. (a) It shall be the duty of the Commission to ~~gather-facts-to-determine~~
26 ~~whether-a-wrong-was-committed-against-these-American-citizens-and-permanent~~
27 ~~resident-aliens-who-were-subjected-to-relocation-and/or-internemnt-by-the~~
28 ~~issuance-of-Executive-Order-Numbered-9066-and-other-associated-acts-of-the~~
29 ~~Federal-Government~~ review the facts and circumstances surrounding Executive
30 Order No, 9066, issued February 19, 1942, and the impact of such Executive
31 Order on American citizens and permanent resident aliens and to recommend
32 appropriate remedies.

33 (b) The Commission shall hold public hearings in Los Angeles, San
34 Francisco,, and Fresno, California; Portland, Oregon; Seattle, Washington;
35 Phoenix, Arizona; Salt Lake City, Utah; Denver, Colorado; Chicago, Illinois;
36 New York, New York; Washington, D.C.; and in any other city that the
37 Commission deems-necessary-and-proper finds appropriate.

38 (c) The Commission shall submit a written report of its findings and
39 recommendations to the Congress not later than ~~eighteen-months-after-the~~
40 ~~date-of-the-enactment-of-this-Act~~ October 1, 1981.

41 Powers of the Commission

44 Sec. 5. (a) The Commission or, on the authorization of the Commission, any
45 subcommittee or member thereof, may, for the purpose of carrying cut the
46 provisions of this Act, hold such hearings and sit and act at such times and
47 places, and request the attendance and testimony of such witnesses and the
48 production of such books, records, correspondence, memorandum, papers, and
49 documents as the Commission or such subcommittee or member may deem advisable.
50 The Commission may request the Attorney General to invoke the aid of an
51 appropriate United States district court to require, by subpoena or otherwise,
52 such attendance, testimony, or production.

53 (b) The Commission may acquire directly form the head of any department,
54 agency, independent instrumentality, or other authority of the executive branch
55 of the Government, available information which the Commission considers useful
56 in the discharge of its duties. All departments, agencies, and independent
57

1 instrumentalities, or other authorities of the executive branch of the Government
2 shall cooperate with the Commission and furnish all information requested by the
3 Commission to the extent permitted by law.

5 Administrative provisions
6

7 Sec. 6. The Commission is authorized to --

8 (1) appoint and fix the compensation of such personnel as may be necessary,
9 without regard to the provisions of title 5, United States Code, governing
10 appointments in the competitive service, and without regard to the provisions
11 of chapter 51 and subchapter III of chapter 53 of such title relating to
12 classification and General Schedule pay rates, except that the compensation of
13 any employee of the Commission may not exceed a rate equivalent to the rate
14 payable under GS-18 of the General Schedule under section 5332 of such title;

15 (2) obtain the services of experts and consultants in accordance with the
16 provisions of section 3109 of such title 5, United States Code;

17 (3) enter into agreements with the Administrator of General Services
18 Administration for procurement of necessary financial and administrative services,
19 for which payment shall be made by reimbursement from funds of the Commission
20 in such amounts as may be agreed upon by the Chairman of the Commission and
21 the Administrator of General Services Administrator;

22 (4) procure supplies, services, and ~~property, and make contracts, without~~
23 ~~regard to the laws and procedures applicable to Federal agencies~~ property by
24 contracts in accordance with applicable laws and regulations and to the
25 extent or in such amounts as are provided in appropriation Acts; and

26 (5) enter into contracts with Federal or State agencies, private firms,
27 institutions, and agencies for the conduct of research or surveys, the
28 preparation of reports, and other activities necessary to the discharge
29 of ~~its~~ the duties of the Commission, to the extent or in such amounts as are
30 provided in appropriation Acts.

33 Sec. 7. ~~{a} The Commission shall, within eighteen months from the date of~~
34 ~~enactment of this Act, transmit a final report to the President and the Congress~~
35 ~~concerning its actions and its findings and recommendations;~~

36 ~~{b} The Commission shall cease to exist on the date six months from~~
37 ~~the date it transmits the final report~~ terminate on February 1, 1982, unless
38 extended by a subsequent Act of Congress.

40 Authorization of appropriations

42 Sec. 8. ~~There are authorized to be appropriated such sums as may be necessary~~
43 ~~to~~ To carry out the provisions of this Act, there are authorized to be
44 appropriated \$1,500,000 for the period beginning October 1, 1980 and ending
45 February 1, 1982.
