

Dear Mr. Yamaki:

This letter is intended to serve as a non-binding letter of intent to state the principal terms and conditions upon which I, whether directly or through affiliates, am interested in purchasing the above referenced property. This "agreement to agree" must be drafted into a definitive Purchase and Sale Agreement and duly executed by all parties to constitute a binding agreement.

The salient terms and conditions of my proposal are as follows:

Purchase Price

Two Hundred Twenty Five Thousand Dollars (\$225,000).

Terms

- "As Is" no termite work or environmental inspections.
- All Cash.
- Deposit to be \$5,000.
- Inspection period to be 45 days.
- Escrow to be 60 days.
