Joint statement of community council and block manager assembly regarding Christmas gift for Hospital workers (as in the original)

Public statement by Amache councilmen

And Amache block managers

All residents could not be thankful enough for the tireless work and dedication provided by the medical workers at the center hospital. As everyone is aware, there has been difficulty adding more nurses to the hospital stuff. As a part of measures to mitigate this, we, the councilmen and block managers initiated a Christmas present drive last December, which must have gathered many residents' sympathy, as we received much more than we could ever asked for. This drive is to express appreciation for the workers who have direct contacts with patients such as nurses and doctors; therefore it is our regret that it does not reach out to everybody who works for the hospital.

As we already announced in Pioneers, we decided to abolish empty formalities. Taking consideration of the fact that we ceased to give out gratuities to mess and other workers of each block, we only gave the gifts to the above mentioned medical workers such as doctors, dentists, eye doctors, pharmacists, specialists, and nurses. Method of distribution is based on the length of the individual's service according to the hospital record, as well as the level of hazard. We also consulted with the head nurse to avoid any oversight. It is also limited to those who are employed currently. We are aware and thankful of the many people who work hard at the hospital.

However, if you allow that hospital workers are also residents of the center, we appreciate your understanding as residents that we had to decide the scope of distribution and the reasons why we had to do so. To express our appreciation, small as it is, to those who did not receive monetary gifts, we were planning to throw a banquet one evening inviting all the hospital workers to enjoy entertainment from the recreation department; and for us to give a speech expressing thanks from a representative of congressmen and block managers. But it is our great regret that we could not reach an agreement with the hospital after many attempts to make it happen. Accordingly, all of

the remaining balance was used to purchase medical reference books and journals, and they were offered to the Japanese doctors. We, the congressmen and block mangers, always cooperated and worked together with the best intentions to process the matter as mentioned above.

Blatant prejudice seen in Santa Maria, CA (2)

Christmas Science Monitor issued on January 7th reported an increase in anti-Japanese sentiment in Santa Maria, CA as follows.

Farmers and entrepreneurs in Santa Maria say that Japanese who are relocated to the back country should not return not only during the war but also after the war.

This ostracism is not due to military nor social reasons, but it is said to be based on clearly economical ones. Japanese farmers' standards directly challenge the standards of American farmers, therefore the relocation of Japanese farmers substantially benefited American farmers. American farmers object to the return of Japanese farmers to keep their benefit. However, Americans on west coast farms are fully aware of how Japanese farm workers are diligent and efficient, and they even say there is nobody better than the Japanese.

For example, when the government imported Mexican workers, although it was an appropriate measure, their standards were much lower than that of the Japanese, and their work was shown to be incomparably weak.

Slaughter house that lacks workers (3)

Center's slaughter house does not have enough workers and is having difficulty providing meats for the mess' weekly needs of 25 swine and 16 cattle, and it is increasingly requiring assistance. Normally the work requires 10 people, however the center only has one Mexican and three Japanese workers.

Farm announces completion of seed order required at the center farm (4)

In order to secure the necessary seeds for the center farm, as well as to purchase them at the lowest prices, orders were placed for a variety of seed products to seed companies all over, the purchase director Meade announced.

Three accused of alcohol intoxication (5)

Police Chief Tomlinson announced that Torazo Hatanaka, Eijiro Kodani, and John Aragaki were accused of intoxication, and as a result of the trial at the Lamer court, the following verdicts were given:

- •Hatanaka=30 days in county jail, however 6 months on parole
- •Kodani=60 days in county jail, however the sentence can be commuted to 60 days of volunteer work at the center.
- •Aragaki = Revocation of clothing allowance for a month.

The 3rd repatriation is expected to be arranged (6)

The American-Japanese non-soldier repatriation negotiation was temporarily suspended. However, because the Spanish government representatives who had been conducting the investigation concluded their report to the Japanese government, the negotiation started going forward, and it was announced that the arrangement is still possible. Because this negotiation is moving forward, the relocation department issued a statement that it will do everything in its power to help people who wish to return to Japan. All those contemplating repatriation and anyone who is applying to return should meet with Willis Hanson, leave officer, immediately and ask for the details. The 1st group departs to the Seabrook farm (10)

Mario Vecchio announced it is decided that the first group consisting of 15 workers for the Seabrook farm in the east is leaving Granada on January 18^{th.} For the ease of transportation, the center has divided people into small groups of 10-15 people to send them off via train.

Following are current information regarding Seabrook farm:

- Those who wishes to work at the farm please inquire Vecchio
- Even if you have already signed for the project, please come to Vecchio's office to receive detailed information
- Those who fulfill the contract terms will receive the full cost of round trip transportation. Those who do not follow through on the contract terms will be paid for their transportation cost according to the length of their work.
- Payment will be based on the workers' union standard.
- Accommodations are managed by the housing department and they include facilities in accordance with government guidelines. Food is provided at an affordable price.
- Six months of seasonal leave.

Receiving refund from Co-op (11)

Business director, Runcorn stated that Amache co-op is a part of Kansas City co-op in northern Missouri and it received a refund of \$1949.35 for the past year.

The refund was given to the center co-op from the co-op headquarters in the form of preferred stock, and it is equivalent to 4% of the wholesale prices of miscellaneous items.

Draft Registration (12)

According to the U.S. draft law stipulated in 1940, it is known that any male who has reached the age of 18 is required to register at the nearest local board; at the center, Luis Fanslan is in charge of the registration processing, and he urges all who apply to be aware of the requirement.

He also manages the information based on the background check reported at the age of 17, male and female.
