

## Ban Private Practice by Barbers, Beauty Operators

The division of community enterprises has announced the opening in the center of three barber shops and two beauty shops, employing altogether 12 barbers and 11 beauty operators. This is a welcome announcement, for these facilities have been urgently needed from the beginning of the center.

Private practice by barbers and beauty operators within the center should now be discontinued. WRA regulations clearly prohibit the conduct of any private enterprises within the center, and the laws of Wyoming provide that only those regularly employed under WRA regulations may practice without first obtaining a state license and meeting all other requirements set up by the center.

Residents of the center are, therefore, requested to patronize the shops that have been provided for them at considerable cost and to discourage private practice by not supporting it and by reporting any violations to this office.
