

WAR RELOCATION AUTHORITY

REQUEST FOR TRANSPORTATION OF PROPERTY

1. I hereby request the War Relocation Authority to transport the personal property listed on the reverse side hereof from the present location, shown below, to destination, shown below, without charge to me except as set forth herein.

2. All agreements made by me herein are made in consideration of traffic services provided in connection with the transportation of my property by the War Relocation Authority, and I hereby acknowledge the value and sufficiency of that consideration.

3. I represent and warrant that I have full right to cause said property to be transported; that I am the sole owner of said property, or that I have obtained written consent to its being transported, from all other parties who have any interest in said property.

5. A. I agree that the Authority may designate the means and route by which the property is to be transported.

B. I choose to have the property transported via XXXX XXXXXX. I shall pay all expense connected with transporting the property. To cover this expense I am depositing with the Authority \$ XXXX under the provisions set forth in Paragraph 7.

6. In the event any of my property is perishable, or is (or becomes) contaminated or if it may lead to the contamination of other property, I authorize the Authority to dispose of such property (or any part thereof) without notice, by whatever method it chooses, without expense to me. If any proceeds are realized from the disposition of such property, those proceeds are to be remitted to me in full.

7. If any commercial property (that is, any property other than clothing, household furniture, kitchen equipment, utensils, and hand tools) is included in the list of my property on the reverse side hereof, such property is to be transported at my expense. To cover that expense, I am depositing with the War Relocation Authority \$_____. If the expense of transporting such property is less than the sum deposited, the Authority will return to me the excess on deposit; if the deposit is not sufficient to cover the expense, I agree to pay, prior to the delivery of said property at its destination, an additional sum sufficient to cover the deficiency. If I fail to make such additional deposit, the Authority is hereby authorized to sell my property or any part thereof, applying the proceeds to such deficiency and remitting the balance to me.

8. Since I have not seen my personal effects and other property for a considerable time and have no reliable inventory thereof, I hereby designate the War Relocation Authority as my agent to cause an inventory to be taken of the property which I am requesting the Authority to transport for me. I have confidence in the integrity

and good intentions of the Authority and its representatives, and I hereby agree to accept as correct subject to any claims I may make in writing within ten days of my receipt of such list, the list which will be delivered to me by the Authority to inform me what goods are being or have been transported for me.

9. I hereby release and discharge the War Relocation Authority and its employees and representatives of and from all liability whatsoever arising out of or resulting from packing, storing, transporting or otherwise handling my household and personal effects and any and all other property belonging to me or in which I have an interest.

NOTICE TO PROJECT DIRECTOR: This form is to be executed in quadruplicate and distributed as follows: two copies to Transportation Section, Evacuee Property Office, San Francisco, California; one copy to project files; one copy to evacuee.

GENERAL INSTRUCTIONS TO HOLDERS OF CITIZEN'S INDEFINITE LEAVE

Your indefinite leave from the Jerome Relocation Center, Denson, Arkansas, is issued pursuant to Executive Order 9102, March 18, 1942, and failure to observe the conditions or restrictions applicable to this leave shall subject you to the penalties provided in the Act of Congress of May 21, 1942, (Public Law 503, 77th Congress). Such conditions and restrictions include:

1. Upon arrival at your destination you will complete Form WRA-147 and forward it to the Project Director, War Relocation Authority, Washington, D. C. The Director will send you a new Form WRA-147. In case you move to a new locality, this new destination must be reported to the Director of the War Relocation Authority on Form WRA-147.
2. In case you make a change of address after arrival at your first destination, you should, if possible, complete Form WRA-148, Change of Residence Report Card, before making the change. If it is not possible to complete Form WRA-148 before making the change of location, this form must be filled out and supplied to the Director of the War Relocation Authority immediately upon arrival at the new destination.
3. You will not enter any military area unless an official pass to enter such area is obtained in advance. The continuance of your leave will be contingent upon your complying with whatever rules or regulations that are imposed by military authorities at such area. Where a restricted or prohibited local area lies along a highway or along a route of a public carrier, no pass or other authorization is required to traverse such area upon such highway or route while remaining with a vehicle in due course of travel.
4. You are expected to abide by all laws of the community and state in which you may reside after leaving this center.
5. This leave will expire at any time that you violate any of the above conditions; and the Director, War Relocation Authority, Washington, D. C., has the right to revoke it if conditions arise, or if conditions now unknown are discovered, which make it better for your protection and in the interest of the War Effort for you to be returned to the relocation center. You will return to the Jerome Relocation Center, Denson, Arkansas, when this has been revoked by the Director and in accordance with Leave Instruction 60-4 paragraph 21 B and C as hereby described:

- (B) Evacuees who obtain indefinite leave are not expected to return to relocation centers except for occasional visits. They are granted leave for the purpose of re-establishing themselves on a permanent basis. If, however, an evacuee on indefinite leave finds it impossible to maintain employment or residence outside the relocation center, he may apply in writing to the nearest relocation office for permission to return to a center as a resident. The Relocation Officer shall carefully investigate the application and make every effort to enable the applicant to remain on indefinite leave. As a last resort the Relocation Officer may certify to the Project Director that the circumstances of a particular case warrant an evacuee's return to the relocation center upon such a certification. If a person upon indefinite leave returns to a relocation center without first obtaining a certification by the Relocation Officer that his return is justified by the circumstances, the Project Director may, in his discretion, admit him. The Project Director shall immediately communicate with the proper Relocation Office if the

evacuee is admitted. If the Relocation Officer then certifies that the evacuee's return was not justified, he may recommend that the evacuee not thereafter be granted an indefinite or seasonal work leave without the prior approval of the Director. The reasons for such recommendation must be stated in full and be incorporated in the evacuee's leave record.

- (C) When a person upon indefinite leave returns to a relocation center he shall be required to surrender his leave card unless he is admitted as a visitor, in which event he shall be required to pay for food and lodging in accordance with the provisions of current Administrative Instructions on the subject.
