Draft Trial Concluded; No Decision Announced Yet

The trial of the 63 Heart Mountain residents charged with failure to report for their preinduction physical examination concluded Monday afternoon in the United States district court in Cheyenne, according to the latest reports received here. United States District Judge T. Blake Kennedy has taken the case under advisement and will announce his decision later, it was said.

In final arguments, defense attorneys asserted that the defendants were unwilling to report for the examinations until constitutional rights which they considered had been violated were cleared up. Assistant United States District Attorney John C. Pickett contended that the accused were sent notices to report for preinduction examinations and had failed to do so with willful intent.
