A BILL

To amend the Civil Liberties Act of 1988 to increase the authorization for the Trust Fund under that Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the "Civil Liberties Act
3 Amendments of 1992".

4 **SEC. 2. AUTHORIZATION FOR TRUST FUND.**

5 Section 104(e) of the Civil Liberties Act of 1988 (50
6 U.S.C. App. 1989b-3(e)) is amended by striking
7 "\$1,250,000,000" and inserting "\$1,570,000,000".

8 **SEC. 3. DEFINITIONS.**

9 Section 108(2) of the Civil Liberties Act of 1988 (50
10 U.S.C. App. 1989b-7(2)) is amended in the matter pre-
11 ceding subparagraph (A) by inserting ", or the spouse or
12 a parent of an individual of Japanese ancestry," after
13 "Japanese ancestry".

14 **SEC. 4. PAYMENTS IN THE CASE OF DECEASED PERSONS.**

15 Section 105(a)(7) of the Civil Liberties Act of 1988
16 (50 U.S.C. App. 1989b-4(a)(7)) is amended by inserting
17 the following after subparagraph (C):

18 "(D) Any person asserting a claim for payment
19 under this section on account of an individual who
20 is deceased shall be required to certify to the De-
21 partment of Justice the names of any living spouse,
22 child, or parent of the decedent on account of whom
23 the claim is asserted. In any case in which the At-
24 torney General makes a payment under this section
25 to a claimant based upon his or her certification
26 that the claimant has informed the Government of

1 the identities of all living spouses, children, or par-
2 ents, the exclusive remedy of any spouse, child, or
3 parent who was omitted from the certification shall
4 be against the claimant who received the payment.”.

5 **SEC. 5. TERMINATION OF DUTIES OF ATTORNEY GENERAL.**

6 Section 105(e) of the Civil Liberties Act of 1988 (50
7 U.S.C. App. 1989b-4(e)) is amended by striking “when
8 the Fund terminates” and inserting “180 days after the
9 Fund terminates.”.
