Chairman briefly reviewed the functions of the Relocation Planning Commission and of the Executive Board.

Mr. Rebertson was naked to report on the Project Director's Conference which was held in Machington B. C. on March 6 to 11. 1944, insofar as it related to the problems of relocation. He stated that all the items on the memorandum given him by the Planning Commission before his departure, had been discussed.

Thereafter, he made the following pointes

- I. The present five hundred pounds limit on freight will be eliminated and the existing regulations will be considerably liberalised.
- The persons in charge of the evacuee property on the Pacific Coast are quite concerned about property stored thereparticularly that in private warehouses. WMA encourages and will make concentrated effort to move all property into government warehouses.
- II. There can be no assurance of increase in grants since the budget is to be further reduced. The WRA will attempt to put more money into the field effice and into public relations in order to give more protection to evacuees and to create more confidence in them.
- III. The idea of a large family hostel was favorably received but the matter will have to be carried by other organi-
- IV. It was considered not a very wise idea to include business opportunity experts in the WRA field personnel. WRA does not wish the evacuees to invest their savings from the start. Evacuees should get acquainted with the communities thoroughly before investing money into business enterprises.
- V. The Community Council will receive a letter in regard to the Mational Myacuce Conference from Mr. Myer. First there will be a conference among the evacuees from the nine centers. Then a Mational Conference will take place between evacuees and WAA personnel. In all probability this will be several menths from now.

- VI. What is aware that there are a lot of people just waiting for their leave clearance after their hearings have been recorded and their leave clearances recommended. The reason for this is that there are thousands of urgent cases on file in Washington. In order to expedite the clearance in Washington, Project Directors have asked that one representative from each center be sent there to work on the cases for their respective centers. They expect to clear them up within the next five weeks. John K. Corbett represents this center in Washington for this purpose.
- VII. Every effort will be made to relocate successfully those who wish to go out but for those who do not intend to leave, the centers will continue to operate.

A question was asked as to whether the savings in expenses by closing the Jerome Center will absorb an appreciative amount of the out in next year's budget.

Mr. Robertson replied that it may effect some changes in the administration but not so far as the evacuess are concerned.

(Mr. Robertson was excused at this time.)

A copy of the memorandum prepared by Chairman Yosh Kodama with materials submitted by the Commission members and the Education Section survey and addressed to the Project Director on the subject, "Inconsistencies in the WRA Program which Retard Relocation," was passed out to each member present. This was used by Mr. Robertson at the Project Directors' conference. (A copy of this is attached to the minutes).

It was reported that Mr. Hatchimonji is working on the compilation of "Questions and Answers" to serve as a handbook on relocation. Every member was asked to cooperate in building up the set of questions.

Since Mr. Hatchimonji, visual education supervisor in the Relocation Division is going to resign to become the councilman of Block 27, the members were asked to recommend someone in his place, No action was taken.

The Chairman stated that the Planning Commission was preparing a handbook designed to give information to evacueess on what their thousands of friends on the outside are doing to help the resettlement program. Evacuees are largely ignorant of the fine work of the Pacific Coast Committee on American Principles and Fair Play. American Friends, Church Groups, Social Agencies, and other organisations.

It is up to the Relocation Planning Commission to carry out some public relations activities among evacuees to dispel this ignorance and to teach them to appreciate the efforts of their fellow imericans in their behalf.

Dick Fujicka gave a report on YMCA Conference of Middle West area which he and Mr. Hakaki attended. Both YMCA AMD YMCA have gone out their way to help the evacuees. They will continue their policy of aiding relocatees, announced by the Mational Council at its meeting in Cotober, 1942. These organizations feel that the basis issue in relocation is favorable public opinion and they have been very active in this field.

Hr. Kodama said that several people have asked about the procedure of getting clearance to work in war plants. This requires completion form PNGO -ID Form No. 58, which is available at the Employment Office. The applicant must tell which company he wants to work for and to what locality he wishes to go or leave this up to the NRA area officer. He also explained that there is going to be a new type of leave called "intermediate leave." This has not been officially amnounced but will be published soon.

Mr. Kodama distributed the pamphlet, "New to Relocation Through a Hostel". He pointed out that the hostels have helped relocate more than 700 people. The result has been very successful because they try to follow through and are in touch with them right along. Information regarding hostel services are available at the Relocation Counseling Section.

Mr. George Makaki was elected unanimously to take the place of Mr. Shig Masumga as one of the three members of the Executive Board. Mr. Masumaga is out on short term loave and he may or may not return to the Center.

Mr. Hatchimonji suggested whether it would be a good opportunity from a public relations angle to send Victory Garden experts out to various communities to give helpful advice as goodwill gesture for producing favorable community acceptance for evacuees, for there are many capable farmers in this camp. The Chairman replied that he will investigate this matter.

Mr. Hawai mentioned in regard to the Pair Play Committee that the Fair Play group has opposed phases of the relocation program. Inasmuch as we are interested in hearing all view on relocation, we should let it be known again that this Planning Commission is eager to consider the criticisms and suggestions of all individuals and groups within the community. We can perform our best service by knowing all the view on the subject. Mr. Modama reiterated the policy of the Planning Commission that this was certainly not a

pressure group giving pressure on relocation. It was pointed out that the Fair Play Cosmittee was not a economic unit nor a participating aid in the resettlement program, but that they should nevertheless have an opportunity to express their views.

It was announced that Mr. Thomas R. Sedine will be here in Beart Mountain the first part of April.

The meeting was adjourned at 11:00 A.M.
