

HEART MOUNTAIN COMMUNITY COUNCIL MEETING  
CONFERENCE ROOM

March 21, 1944  
Tuesday

Meeting was called to order by Mr. Nakashima, Chairman. Minutes of afternoon session on Tuesday, March 14 was read and corrected as Labor Committee instead of Legal Committee in paragraph 6.

Mr. Hayashida, Community Enterprises Committee, reported regarding the reduction of the price of The Sentinel to one cent a copy. Mr. Mechau explained that such action would be impractical at this time. The average cost of having the paper printed is \$131.00 per issue. Advertising revenue brings in approximately \$50 per issue while the sales amount to an average of 4,500 copies or \$90.00. Meantime, the Sentinel is planning a supplement in the form of a memorial edition, complete with photographs and historical background of Heart Mountain.

COMMUNICATIONS REVIEWED:

Letter from M. O. Anderson on resolution concerning police uniforms and relationship with Spanish Consul and request for certain types of information; from D. M. Todd on appointment of block manager; from Susumu Umemoto on up-to-date list of Judicial Commission Representatives; and a card of appreciation from Mrs. John D. McGowen.

It was reported by Food Committee that approximately 19 full barrels of shoyu from Red Cross will be delivered to block managers office by March 23, 1944. Distribution to the residents will be handled by each block committee.

Mr. Nagumo, election committee for Block 17 election, reported that Mr. Saoru Saijo of Block 17 was elected councilmen and will occupy the vacancy due to Mr. Paul Motoyoshi's resignation. Mr. Motoyoshi introduced Mr. Saijo.

Mr. Nagumo requested that 100 copies of the letter from the Department of War be printed and distributed among the Council and Block Managers group. The translation in Japanese will be published in a special bulletin.

The term for the Judicial Commissioners should be fixed upon. The Council referred the matter to Legal Committee to draft the regulation.

Mr. Matsushige, Welfare Committee, reported that it is advisable to draw a will before the death, especially in the case of aged bachelors. The money will go into the State Treasury unless the will is made.

Mr. Tsunokai reported that since the death of Mr. McGowen the investigation for Community Enterprises will be postponed until the arrival of another Project Attorney.

Mr. Katagi, Labor Committee, requested to ask Mr. Sakaguchi to attend the Council meeting and discuss the matter of internal workers in the Center. It was approved unanimously.

Mr. Nagumo requested that the Fair Labor Practice Board should be organized immediately. It was seconded and passed unanimously.

Mr. Nakaki reported the facts outside of the Center and emphasized the strong organization of U. S. O. and recommended Council to take action to show sympathy to the wounded soldiers from the 100th Battalion.

Meeting was adjourned at 11:40 AM.
