COMMUNICATIONS REVIEWED:
Letter from Poston Community Council on acknowledgement of our
letter requesting the survey of center employees, from Mr. Anderson
a memo on food, from Japanese American Committee for Democracy
requesting the number who desire further distribution of its
paper, "New York Jiji".

1. Mr. Gilmore, Relocation Officer, representing Mr. Joe Carroll,
who was unable to attend because of illness, gave arrors that
they received teletype from Washington that it is giving special
consideration for leave clear mess and are clearing about 225
a day. About ten days ago it questioned that there were too
many on the stop file and that any man who is willing to go
for pre-induction physical examination are entitled to immediate
leave clearance. Washington agreed that they are clearing these
persons immediately as they are notified.

2. Mr. Joe Carroll will be attending a Relocation Conference in
Chicago from April 18-22 inclusive, and he requested from the
Council any suggestion concerning the relocation program.
The first two days willbe meetings between the Relocation
Program Officers and the Field Officers and the next three
days will deal with relocation program attended by Program
Officers from the nine projects. Mr. Carroll requested
suggestions from the Council regarding simplification of general
leaves and cash grants.

3. Mr. Hayashida, Block 8 Councilman, was elected to succeed Mr. Fujimoto as Vice-Chairman of the Council. (12 votes)

4. The Council approved proposal to participate in the program to honor inductoes on Thursday morning at 8:30 AM.

Mr. George Nakaki was elected to represent the Council as speaker.

5. After discussing the request of Mr. Dave Yamakawa, CA Board of Trustees, made decision that it request to the Community Activity to discontinue operation of pool hall immediately. Secretary was asked to submit memo to this effect to Dave Yamakawa.

6. Mr. Anderson announced that he can arrange for Mr. Kurtz and Dave Yamakawa to meet with the Council's Recreation Committee whenever desired; and also Mr. Ryan and Mr. Erdman to meet with the Council to explain WPB regulation. He agreed to send a copy of regulation.

7. Mr. Anderson was questioned as to whether it is possible to change WR regulations. He advised that such regulations representing policy are subject to change or modification. He also stated that the problem of shortage of doctors is acute at every center, and chief medical officer at Washington is giving careful consideration. He assumed that doctors at Jerome will be sent to centers where need is most acute.

8. Council approved to send a letter of strong appeal to Washington for more doctors. Secretary was asked to draft a letter.

9. Mr. Saito's request was approved by the Council to request the cooperation of Mr. Anderson to appeal to the WRA to send doctors in proportion to the transferees to be sent here from Jerome Relocation Center. Secretary was asked to submit memo to Mr. Anderson.

10. An inquiry concerning type and amount of household supplies allotted to the residents of other TRA centers was approved and the secretary was asked to send a letter of inquiry to all centers.

11. The Council agreed to request publication of Social Welfare regulations in Japanese and English after its modification by Welfare Conference in Washington.

12. Mr. Matsushige announced that application from residents for assistance to meet emergency needs will be accepted by the Social Welfare Department. Its adequate attention will be requested from the department to the doctors.

The Council decided to distribute the recreational gifts to sent to the evacuous from the Japanes Red Cross as follows: All books to the Community Library; goh to goh club; shogi to shogi club; musical instrument to Mr. S. Hara, CA Adult Supervisor.
