Roll Call: Mr. G. Tani was absent.

COMUNICATIONS REVIEWED:

Memos from M. O. Anderson: Copy of Mr. D. Myer's speech, "Relocation Problems and Policies"; Victory Garden Program; Physician Services within the Center; Transfer of Evacuee doctors from Jerome with copy of Mr. Robertson's letter; Poultry Far Dispute; Procedure of handling questions between the Community Council and the Administration; from Dale Morioka, Block Coordinator under the Community Activities, a request for exchange of respective body's minutes; letter from Mr. H. Iwasaki in appreciation of cooperation during his stay at Heart Mountain and enclosure of pictures of the Council body in action; and from Jerome Community Council on acknowledgement of receipt of informations about Heart Mountain Relocation Center and the list of Evacuee Doctors names.

- 1. Mr. Y. Kodama, Executive Secretary of Relocation Planning Commission, explained our status as to relocation leaves and the Council unanimously approved the recommendations for more liberal Relocation Policy from WRA Center to Relocation Program Officers Conference in Chicago.
- 2. Mr. Takahashi, Health and Sanitation Committee, reported that plans to show T.B. films is being arranged with C.A.
- 3.Mr. Tonooka reported that instead of giving a dinner to the winner of "Clean-Up "sek", it will be served to all blocks in appreciation of the splendid efforts rendered.
- 4. Mr. Tokimasa, Logal Committee, give a report that draft of the Arbitration Commission will be studied by Project Attorney.
- 5. Council asked Chairman to visit Mr. George Tani who is confined at hospital.
- 6. Mr. Matsushige made a motion, approved by the Council that a report on Poultry Farm Dispute be made after final decision is made by the committees
- 7. The shortage of "daikon" for center consumption was reported by Mr. Tonooka and the Chairman requested the Agriculture Committee to investigate acreage for this year.
 - Request from Block Nine for laundryroom windbreak was considered. The Council decided to submit request to Mr. Anderson for the construction of windbreaker at entrances to all laundry rooms.
- 9. Mr. Naguno's motion was seconded and approved to establish better understanding and coordination between the instructors at High School and the people of the block-two representatives from each block is to be elected.
- 10. Mr. Nagumo was elected to the Education Committee.
 - 11. Council recommended Mr. K. Suzuki to succeed Mr. A. Nose, Assistant Steward, and Secretary was asked to send memo to Mr. Anderson.
 - 12. Mr. Matsushige of Social Welfare was asked to investigate the distribution of old clothes at warehouse to the residents.
 - 13. It was announced that there will be a special meeting at 9:00 AM, Monday. Dr. Irwin will be present to explain the hospital situation.
