City Planning Board Formed

Formation of a city planning board to create a zoning map of the center and to make recommendations regarding the planning of center physical facilities relating to the welfare of the community was announced this week by C. E. Rachford, project director.

The board, made up of colonists recommended by the chief of each division, met twice during the week to organize and act upon urgent matters. The meetings were under the direction of William M. Friedman, chairman, and were attended by the following designated as members:

George Ishiyama, representing community enterprises; Richard Komatsu, war works; Bill Hosokawa, reports division; Paul Nakadate, alternate for Rikio Tomo, community services; Saige Okazaki, transportation and supply; Toshio Hoshida, administrative division; Raymond Iriye, employment and housing.

Rachford announced that the board will make its recommendations for an undetermined period to the project director, and thereafter to the city council. The board's first report, dated October 14, was submitted to the project director in time to be placed under discussion at an administration staff meeting on October 15.

The board recommended that the high school building be located in blocks 13 and 16 with the industrial shops to be used in connection with the school program to be placed in some other suitable area. It also recommended that if possible space be reserved in these blocks for use by community enterprises, provided it is found desirable to locate various services centrally.

The board drew up a schedule of priorities for the project construction program based on protection and safety of the project and its residents, comfort and convenience of residents, and work and operations. It recommended that large projects be undertaken in the following order:

High school, elementary school, garage and shop buildings, coal storage bunker, unloading platforms at the railroad siding, a second fire station and fire tower, rebuilding of burned laundryroom in block 6, reinforcement of recreation buildings now being used as stores, root cellars, hog houses, chicken houses, garbage treatment facilities, clay products shop, addition to administration building, box factory and other industrial shop buildings, maintenance building, addition to present fire station, adequate housing for community enterprises.

The small projects list in the order of urgency is: asbestos over mess hall canopies, direct exits from women's lavatories, construction of library in 15-25, block administration offices, addition to hospital out-patients' waiting room, warehouse bins and shelving, nursery schools in recreation halls, posting of area boundaries. It was pointed out much of this work can be started immediately.

Other projects recognized as necessary were not given a number listing because of the relative remoteness of the need. The board prefaced its report with the recommendation that an adequate communications system be provided for emergencies. The board also recommended that construction of living quarters for Caucasian personnel be pushed to the extent that it does not jeopardize the building of more immediately necessary projects.

Issue Mackinaw Jackets to Workers

Issuance of navy blue mackinaw jackets to all workers began yesterday morning, according to Philip W. Barber, community services head. Forms C-WRA-76 have been distributed to the various department heads. Workers must fill out these forms in duplicate, then apply in person at warehouse 19 in order to receive their jackets, Barber stated. Women workers are also entitled to the jackets.

Thomas Durning, WCCA clothing official from Santa Anita, is expected to arrive to make clothing adjustments, according to J. Koide, block chairman of 29 and former Santa Anita resident.

There are limited stocks of underwear, shirts, trousers, and other clothing at the warehouse which will be distributed by the social welfare department to needy colonists. Application for this clothing must be made through the social welfare office, 24-25. After investigation and approval by the group, the necessary clothing will be issued at the warehouse upon presentation of the clothing form provided by the social welfare, Virgil Payne, welfare counselor, revealed.

Payment of Sales Tax Explained

The state of Wyoming has a law requiring the payment of a two percent sales tax, and it has been ruled by the state tax commission as well as counsel for the WRA that this must be paid by residents making purchases from community enterprises, stated Douglas M. Todd, division head.

The matter was studied carefully by WRA officials, but there appears to be no way to avoid payment of this tax. Further study and investigation is under way regarding the matter.

Under federal law community enterprises is required to pay a 10 percent tax on all luxury items, declared Todd. Rather than pass this tax on to the customers, this department is endeavoring to absorb this tax out of its own profits. Items being sold at the stores coming under this category are few.
