

KNIFE-WIELDER THREATENS D.H.16 COOKS

Charged with brandishing a butcher knife and threatening the cooks at D.H. 16 during the special dinner on Thanksgiving Day, Noboru Hashimoto, 21-year-old kibeï, was taken Monday, in the custody of Capt. Clarence Lee, to the Jerome County Jail at Jerome to stand trial.

Hashimoto, who lives at 16-10-B, was said to have been under the influence of liquor when he created the disturbances in D.H. 16, according to the complaint filed with the Internal Security division by a resident of the block.

The young kibeï first had his dinner at D.H. 14 from where he was ejected when he persisted, despite warnings, in heckling and booing a Mr. Mori who was making an announcement.

539 STILL UNPAID, TO GET SEPT. PAY

Five hundred thirty-nine workers, still unpaid, will receive their September pay soon after December first, Clarence H. Hurst, fiscal accountant, disclosed this week.

Of this number, 226 are dining hall workers, 200 are housing and employment workers, 73 are motor pool workers and 40 are block managers.

Sewerage Will Be Completed By Mid-December

Long delayed by the lack of material, Hunt's sewage disposal plant will be completed by December 15, according to an announcement by the United States Engineers.

The disposal plant, located west of Blk. 21, will be of the purifying type with a chlorine solution changing solid matter into liquid form so that pipe lines can dispose it outside the center.

NEW LEAVE SECTION FORMED: 30-DAY FURLOUGHS ABOLISHED

All permits to leave the relocation area, whether of temporary or indefinite duration, must hereafter be secured through the new leave section established this week as a sub-division of the Employment Division, according to announcement Monday by Placement Officer Harold James.

Simultaneously, James announced that short term leaves, or 30-day furloughs, will not be granted hereafter in compliance with latest instructions from WRA regional headquarters in San Francisco. This will not apply to harvest work, it was explained.

The new leave section, which will have its quarters in the recreation hall across from the administration building, will be headed by Ray Yamamoto who will assume the title of Supervisor of Furloughs. Heretofore, he was administrative assistant to Philip Schafer in

charge of the furlough section.

The same procedures as have been used so far must still be followed by those wishing to secure permits to leave the relocation area, James said.

Regarding the short term leave, James pointed out that Administrative Instructions No. 22, revised, reads as follows:

"A short term leave is not intended to permit an evacuee to accept employment outside the relocation area, and shall not

In addition, persons who have plans for working as farm laborers next spring or summer must apply for clearance on WRA Form 126.

To prevent confusion and delay at the time of departure, workers are advised to apply now.

Then he proceeded to D.H. 16 where he was told that residents of that block had to show tickets, issued the preceding day, in order to be admitted. He was further told that his share of the turkey dinner had been taken to his home by a member of his family.

Nevertheless, Hashimoto, now angry, went in the dining hall, picked up a dish and threw it at the dishwashers. He then sauntered out but came right back

in with a ready-to-fight-anybody pose.

He made his way into the kitchen when he slipped and fell, his hand going into the soup pot. He then picked up two butcher knives which were laying on the kitchen table and hurled one wildly toward the cooks but it hit the ladles and spoons hanging over the table and caused no damage.

Three residents of the block, two of them nisei, forcibly ejected him from

the dining hall.

Internal Security wardens who had been notified arrived soon thereafter and took the kibei youth in custody.

Records of the Internal Security division show that Hashimoto, last July in Area D in Camp Harmony, had been lodged in the Pierce County jail for a similar offense. At that time he had also taken a knife and threatened a cook who had told Hashimoto not to take too many matches from the kitchen.

HERE *and* THERE

• with max morinaga

We read with great interest a brief AP dispatch the other day, reporting the arrival from Honolulu of a contingent of Hawaiian-Japanese evacuees at the Jerome relocation center in Arkansas. Included in the group, composed largely of women and elderly people, were aliens as well as island-born Japanese, numbering 107 in all. This, as we understand it, is but the first of a series of contingents to be evacuated from sunny tropical Hawaii to the cold vast mainland.

Tears flow copiously when a vessel departs the port of Honolulu. Even so cynical a novelist as Somerset Maugham, after a brief visit, was visibly moved as his ship started to pull out of the harbor.

We remember the face of President Roosevelt on the day he left Honolulu aboard a warship after a few days' visit in the summer of 1934. Thousands were gathered at the pier. The band was playing lively nautical tunes, and FDR was smiling and waving his hat from the deck of the warship. Pretty soon, as the cruiser began to steam out of the harbor and the band began playing Aloha Oe, FDR's smile vanished and a thoughtful expression took its place and it was plain to be seen that he was feeling the sadness of taking leave of blue Hawaii.

At a friend's apartment the other evening, we heard the complete phonograph recording of Beethoven's Symphony No. 7. So long as we can listen to Beethoven and Brahms and Franck and Puccini, we don't mind at all if a dust bowl turns into a duck pond! Such is the influence of great music on our simple souls.

One night, more from curiosity than anything else, we attended a meeting of the drama club. Anybody who wants to cultivate a fine speaking voice should attend the drama club weekly sessions.

MALNUTRITION COMMON IN JAPAN, DR. McSPARRAN NOTES

"A great deal of malnutrition, especially among the low economic class, exists in Japan--infantile rickets and beri-beri being very common ailments."

"Since the Pacific war, food has been rationed in Japan but some of the pressure has been relieved by the importation of food from the occupied territories."

These and other observations were made by Dr. Joseph L. McSparran, who practiced medicine in Japan for the past quarter of a century, at an informal discussion held Sunday evening at the project hospital.

Dr. McSparran is presently connected with the WRA Health Division.

He reported that the status of women has improved in Japan, with women very active in the industries and various professions--more so than in the United States.

Dr. McSparran declared that 24 of the 25 years he spent in Japan were pleasant and ideal, but the last year of his stay was far from pleasant.

Because he was also medical adviser to the Ameri-

can and British consulates and suspected of possessing some knowledge of military value, he was held in solitary confinement for six months and nine days at Yokohama.

He said that the treatment he received during that period was "neither comfortable nor easy to endure."

He left Tokio last June 25 and after stopping for a few days at Hongkong, Saigon and Singapore, he boarded the exchange ship Gripsholm at Mozambique, East Africa, and arrived in New York August 22.

Dr. McSparran left for the Central Utah Relocation center at Delta, Tuesday.
