Depota, the Ver Dopartment has agroed that persons of Japanese ancestry who are frec to travel anywhoro within the United States may make application and will be accoptod for employment at Ordnance Dopots in oxactly the same mannor as any other citizon applying for ordnance depot work, Relocation Program Officer Valtor A。 Heath disclosed.

He said that this will moan that it vill no longer bo necossary for evacuees to fill out the Personnel Security Questionnaire and obtain a prior clearance from the Provost Marshal Gonoral's Office before going to work.
