Evacuee Property Division will supply and deliver lumber for crating of personal property of segregants for shipment to Tule Lake, said A.F. Chamberlin.

Each family will be contacted by printed notice through block managers. Prompt response is requested as each family head must secure transportation forms.

Deliveries of necessary lumber for the first group (Oct. 1) will begin today.

Many segregants have unfinished business with the evacuee Property office which must be cleared or transferred before departure.

Instruction for baggage and freight identification, packing, and inspection may be obtained from block consultants.

CANAL RESIDENT TO ELECT 17 PERMANENT COUNCILMEN

Canal residents will vote Tuesday, Sept. 14, for the men who will be empowered to legislate much of the internal policies of their community.

Each of the 17 blocks will elect a councilman. These will form Canal's first permanent governing body. The term of office is six months.

For the second time this week, rumor mongers in Canal have been disappointed. The latest rumor that 16 dollar jobs would be lowered to 12 dollars was squelched by William Huso, employment supervisor.

The fact: All \$16 jobs will stay a \$16. Some trainee positions will be opened for \$12. What these will be has not been determined yet, however, no \$16 positions will be lowered to \$12.

Freight pick up, tally in, warehousing, and shipping will be handled or supervised by the Evacuee Preparation office.

All arrangements for the election were prepared by the three man election commission.

One of the important powers of the council will be that of soliciting and administering funds and property for community purposes. It is also empowered to enact laws, ordinances, and regulations for the government of the community and to provide penalties for violations.
