## AMACHE MP'S TRANSFERRED TO WYOMING

AMACHE, Colo.—Sixty-three members of the Military Police Escort Guard Company stationed at the Granada relocation center left October 23 to take over the guarding of the Heart Mountain center.

Heart Mountain's MP company, it was learned, has been transferred to the prisoner of war camp at Fort Robinson, Nebraska.

According to Granada's project director, James G. Lindley, "This will involve an increase in the commissioned personnel and in the enlisted strength, but it means a decrease in the size of the escort guard at each center."

Five internees paroled from the Santa Fe internment camp arrived here Saturday afternoon to be reunited with their families, it was announced today.

They are Shichisaburo Akashi, Tsurumatsu Saiki, Tajiro Baba, Suyeto Fujiwara and Misaku Nakamura.

## 35 TOPAZ WORKERS FIRST GROUP TO ARRIVE AT TULE LAKE CENTER

The 35 residents who went to Tule Lake to harvest the vegetable crop were the first group to reach there, according to a wire received from Theodore Lewis, internal security head, who accompanied the contingent.

The wire stated: "Arrived at project 10 P.M. Sunday, Oct. 31. Came through in good shape. Were met in Klamath Falls and transported to the farm in trucks. We were first group to get here."

## NEGRO AUTHORITY ON RACE ISSUES TO SPEAK TONIGHT

James Farmer, co-secretary of the race relations department of the Fellowship of Reconciliation, will speak tonight at dining hall 32, 7:30 P.M.

Farmer, one of the organizers of the Committee of Racial Discrimination, is also associated with

the National Council of Methodist Youth and the Christian Youth Council of North America. His visit is sponsored by the Protestant Church.

Farmer's particular concern is in giving people a thorough analysis of the job to be done in removing social, economic and political causes of race tension by the Gandhian principles and technique of non-violence.

It was reported that Farmer, who received his degree in theology at Howard University, famous school for Negroes, can make a valuable contribution to the thinking of nisei by analyzing creative approaches to some of the typical problems of discrimination which are holding back many nisei from relocating.

## POST OFFICE

### 4500 LETTERS HANDLED DAILY

Approximately 4,500 letters are handled at the center post office daily, according to R. C. Thicker, clerk in charge.

Mail has increased within the past 2 months due to the transfer movement. 1,500 letters are delivered to the residents each day and 3,000 are sent out from the center.

Out of that number, 450 are air mail messages. Packages handled at the post office number 125 daily.

An average of 363 worth of stamps a day are sold and 75 money orders are issued, it was learned.

## DR. E. STANLEY JONES DEPARTS

Climaxing the evangelistic tour of the National Preaching Mission to Topaz, Dr. E. Stanley Jones, eminent missionary to India, left Saturday for Wyoming, en route to Canada and Cuba.

During his stay here, Dr. Jones spoke at 2 mass assemblies in the new auditorium Thursday and Friday nights. He also addressed the morning watch Friday and Saturday, and the high school students Friday.

## TULE DOCTOR TO JOIN TOPAZ STAFF

Dr. Henry Sugiama of Tule Lake will be transferred to Topaz to join the hospital staff here, it was reported today. He is scheduled to arrive at Delta tomorrow afternoon.

Nineteen other key workers are also expected to arrive from Tule on Thursday morning, according to a wire received yesterday.

According to a WRA announcement last Thursday concerning the refusal of Tuleans to harvest their farm crop, the "officials of Tule Lake recognize the strike as being the work of experts. A truck accident which resulted in the injury of several and the death of one farm worker was seized upon as an excuse for the strike."

Most of the known ring-leaders of the strike are from Hawaii, Dillon Myers said Saturday. A committee of 8 called on Tule Lake officials and informed them of the determination not to help harvest root crops which were to be sent to other centers.

Permission to sue the Dominion Government to test its power to sell Japanese owned property in British Columbia has been granted through the issuance of fiat in response to 3 petitions sent to the Secretary of State several months ago, the Japanese property owners' association has been officially informed.

The petitions of a Japanese national, a naturalized Japanese and a Canadian-born Japanese were granted recently and have been forwarded to the Exchequer Court, where the cases will be tried in due course, according to the New Canadian.

The war food administration of Millard county has set up a farm labor camp in Delta for Topeka workers in the area, said Claude C. Cornwall, chief employment officer, today.

The CCC barrack buildings with new concrete floors and shingled roofs will accommodate 30 workers. Extra beds and mattresses from the Provo FSA camp were transferred to the camp, and kitchen equipment was installed early this week. Approximately \$1 will be charged per day for board and lodging.

As resident manager, Roy Takari will assign labor crews to various camps, in co-operation with Glen C. Stewart of the war food board.

For the first time in the history of Topaz, an inter-sectional football contest will be held here on the local gridiron when the Delta High School Rabbits play the local Rams this afternoon at 3 o'clock.

Topaz will enter the game as favorites for the first time this season by virtue of a victory over the Rabbits last week, 13-7. Since that win, Topaz dunned the Fillmore Eagles, 18-8. Fillmore also has a victory over the Rabbits.

Sparkling the Rams' attack will be snivel-kipped Yosh Yamada, halfback, who reeled off yardage after yardage in the Fillmore

clash last Friday, including a 70-yard touchdown dash.

Sneedy Sus Iwasa, heavy ground gainer in the Fillmore brawl, George Hamada, brilliant open-field runner, captain Roy Harano, brains of the outfit, Sock Yoshida, Harry Kitano, and Sam Nakaso will lead the offensive for the Rams.

Topaz's front line, which has held Fillmore and Delta to one touchdown apiece, will be led by Hisao Sano and Mike Hayada, ends, Willy Hamada and Ky Tanamachi, tackles, Mac Yoshida and Yosh Takahawa, guards, and Stan Tsujisaka, center, Mas Taketoshi, guard, Kenzo Ishimaru, tackle, Ike Nakamura, center, and Paul Bekk, end, will be ready to plug-up any weak spots on the line.

In the Fillmore tussle, the Rams gained 270 yards through running plays and 100 yards via passer. Fillmore made 75 yards by rushing but none via air. Topaz lost 29 yards while the Eagles lost 21 yards. The Rams made 5 first downs to Fillmore's 2.

The only passes that gained yardage for the Topaz eleven were the touchdown tosses by captain Harano and Sambo Nakaso, one good for 60 yards and the other for 40 yards.
