FINAL ELECTION RESULTS SHOW 28 ARE RE-ELECTED

As final returns of yesterday morning's council elections were tallied, results indicated that of the 33 successful candidates, 28 were members of the previous governing body. Thirty nominees, representing 91% of the council members, took office by acclamation.

Because no candidates were nominated in block 8, election was postponed in that block.

The new council will hold its first meeting tonight at the council chambers. John Province, chief of the community management from Washington, will be present to observe the council in session. He will probably address the group on its functions. It is expected that a chairman for the council will be named at tonight's meeting.

The newly elected councilmen will serve for 6 weeks --- the unexpired term of the former council.

18 TOPAZ WORKERS RETURN FROM TULE

Eighteen Topaz workers who went to Tule Lake to harvest the center's potato crop several weeks ago were due to return here this noon, according to word received by James F. Hughes, deputy director. The remaining 15 workers have extended their leaves to visit in Salt Lake City.

Before departing, the workers received the personal thanks of Tule's project director, Ray Best, and others connected with the agricultural program there.

ODC TO CONTROL DEC. 17-JAN. 10 CIVILIAN TRAVEL

In accordance with the latest regulations of the office of defense transportation curbing civilian travel through the period from December 17 to January 10, Dillon S. Myer, national WRA director, solicited the co-operation of the relocation centers.

With the exception of travel that is necessary for those evacuees with indefinite leaves, visiting between centers should be discouraged, Myer said. Traveling would be a conspicuous violation of ODT instructions.

This order does not apply to soldiers desiring to visit centers during that period, or to evacuees desiring to visit soldiers.

Relocation officers should contact relocators in their areas to intercept any anticipated visits during that period to the centers, it was stated.

HIRANO NAMED MANAGERS' HEAD

James Hirano, acting chairman of the block managers for the past 5 months, was appointed permanent chairman last week. He succeeds Frank Yamasaki who acted as liaison officer for Topaz at the Provo tent camp.

Yamasaki, now visiting Heart Mountain, is expected to work in some phase of the relocation program when he returns.

PILGRIM'S PROMENADE SET FOR TONIGHT


