NOTHER TRAIN LEAVES SEPT. 28

Project Director Ray D. Johnston received confirmation Wednesday that another special train will leave the project for the West Coast Area on Friday September 28. Mr. Johnston said, "Because of the cooperation of the people in making their wishes known in advance it was possible for us to justify another request to the army and the ODT for the necessary railroad equipment. By coming in and signing up ahead of time these people made it possible for others to have travel accommodations that would not otherwise have been available. Their helpful attitude in this matter is very much appreciated."

There is still room for other passengers, stated Mr. C. B. Price, Relocation Program Officer; and applications will be accepted through Monday, September 24. Mr. Price explained that 4 days were required to prepare the necessary papers and make arrangements for shipping property.

The train is expected to arrive at 8 A. M. and loading will start immediately. It will consist of a diner, two Pullman cars and six coaches. The Pullman quota will be filled by cases that have been certified as eligible for special accommodations by the Chief Medical Officer.

Picking up of checked baggage will start at 8 A. M. September 27, the day before the train leaves. All checked baggage should be ready and placed on the roadside. If it is left in the apartments or between the barracks it may be overlooked.

Passengers are especially requested to come to the train only in the trucks that are supposed to pick them up and to board only the cars assigned to them. Otherwise, the pick-up sheets of the truck drivers will not check and the people cannot be properly checked in at the coaches.

SOME FORT SWELLING GRADUATES TO GO TO JaPAN

Fort Smelling, Minnesota - Graduates of the Army's language school at Fort Smelling, the majority of whom are americans of Japanese ancestry, "will be key men in the reducation of Japan's youth," Major Paul F. Rusch, director of military procurement at the language school, declared this

week as he was alerted to join the General "endquarters of the American occupation forces in Japan.

Major Rusch declared that the Fort Snelling graduates who will make up a part of the American occupation forces in Japan. "will be instrumental in building the kind of world of racial understanding we must have if there is ever to be a

hope for permaient peace."

Major Rusch, who spent 18 years in Tokyo as a member of the faculty of Rikkyo University, visited Rehwer when Language School recruiting first started and interviewed and signed up several boys from this center.

NEWS OF ROHWER RELOCATEES

St. Louis, MO. - Mr. and Mrs. otaro Arimura and their four children are one of the first Rohver families to take advantage of Federal Housing for families of veterans. They moved into the Powell Terrace Housing Project, St. Charles, Mo. on September 13. This project is operated by the Federal Public Housing Authority and consists of 324 housing dwellings - single dwellings, duplexes and four-plexes, with one, two and three bedroom units. It is within walking distance of any part of the town of St. Charles. A grade school is just two blocks from the project and a high school, four blocks.

the project and a high school, four blocks.

The maximum rental for a three bedroom unit is \$32.50 per month and a two bedroom unit, \$27.50. The project has approximately twenty units available for occupancy at present. A family having either a husband or children in the service is eligible to make application for rental privileges. St. Charles, Missouri is located 26 miles from St. Louis nd has a population of 10,500 persons. There are several shoe factories and a car manufacturing company located in St. Louis, and in addition, the county of St. Charles is considered one of the richest farm communities in the state of Missouri. Factory work and farm work is available at present.

Kansas City, Missouri. - Lily Matsushita, daughter of Mr. and Mrs. Hideichi Matsushita who formerly lived at Rohwer and Los Angeles, has entered High School in Kansas City. When the public schools there started, September 4, there were 12 Nisei Grade School students attending, and 11 High School students.

Kansas City, Missouri. - Miss Katherine Sachi Ashiwagi, a 1945 honor graduate of the Pasco High School in Kansas City, Missouri, who returned to Los Angeles early this summer visited the Kansas City WRA office on her way to Chicago where she is to enter the Nursing School affiliated with the Cook County General Hospital. Miss Kashiwagi and her mother, Mrs. Haru Ashiwagi, had relocated to Kansas City in December of 1943, from Rohwer.

St. Louis, Mo. - Fred Oshima of Rohwer and Lodi, California took "top honors" in a competitive examination for draftsmen iven by the U. S. Civil Service Commission which resulted in his receiving an appointment as draftsman with the U. S. District Engineers "ffice in the Federal Building, St. Louis. Fred will start to work on September 10, since he was just laid off from his defense work job. "he is the only American Japanese worker in the St. Louis district laid off from defense work. Fred's personal reconversion resulted in his obtaining a better job in government work at just the right time.

St. Louis, Mo. - Among the fifteen members who were elected to serve next year on the Nisei Council of St. Louis, were the following people from Rohwer; Stewart Nakano, from Lodi; Ted Ohashi from San Francisco; Fred Oshima, and William Kagawa, both from Lodi. Plans were made for the studying of an organizational set up to take the place of WRA upon WRA's closing. The Nisei Council voted to take the initiative in asking the Issei Resettlers Resettlement Committee and the Advisory Committee of the Social Planning Council, to constitute a committee to study the type of organization that would best serve St. Louis resettlers upon the closing of WRA.

JEROME RESIDENT VETERAN OF WORLD WAR I & II

Chicago, Illinois - Tec 3 James Yoshinobu, berry farmer of Torrence, California, prior to evacuation and veteran of Worldwar I and II, has been visiting his family in Chicago while on a furlough following action with the 4gh Marine Division on Iwo Jima. DEPARTMENT OF JUSTICE STATEMENT CONCERNING INTERNEES

Washington, D. C. - Following the War Department announcement today that the Department and the Western Defense Command have terminated military controls of persons of Japanese ancestry previously excluded from the West Coast, Attorney General Tom C. Clark made known that approximately 6700 resident Japanese have been ordered interned by the Attorney General either at Justice Department camps or at the War Relocation Authority Segregation Center at Tule Lake. "The action of the military authorities," Mr. Clark said, "will have no effect on the status of these

Included in the group to which the Attorney General referred are approximately 5500 persons of Japanese parentage born in the United States who have renounced their American citizenship and are presumed to be nationals of Japan. The balance are foreignborn Japanese interned as alien enemies for the duration of the war.

"These persons," Mr. Clark said, "will be continued in internment pending final review of their cases by the Attorney General and approval by the military authorities of the removal

of hostile Japanese nationals to Japan."

In addition to the 6700 interned Japanese who are residents of the continental United States, there are in Department of Justice internment camps approximately 1000 Japanese nationals from Hawaii, Alaska and various Latin American countries and approximately 2000 voluntary internecs. An additional 2500 Japanese aliens are on parole orders issued by the Attorney General and have their activities supervised by the Immigration Service.

The ceremony took place Setember 11, 1945 and was attended by WRA Director, Dillon S. Myer, Secretary of the Interior Ickes and Mr. Earl Finch, of Hattiesburg, Mississippi. The event was given wide publicity in Eastern papers.
