Persons who have as yet not received their coupons and who intend to leave the Center will be given ration books 1 and 2 at the time of their departure.

FIELD AGENCIES OUTLINE PURPOSE

The purpose of the offices is to serve as the agent for employers on the outside and potential employees inside the Project.

Employment offers which are referred to projects by relocation officers of the WRA are checked to see that (1) prevailing wages will be paid, (2) the communities are reasonably

favorably disposed and (3) if employment is in a unionized plant, that the union will not object to an evacuee taking the job.

"We request all those who have porches now not to tear them down in the hopes of getting new ones because the actual number of apartments needing porches have been tabulated," said Tom Makino, resident architect.

This article is the third in the series of articles covering the functions of the Evacuee Property office.

It is a part of the WRA Evacuee Property office that it does not act as a substitute owner, director or operator of property. The evacuee owner retains control at all times and directs what action is to be taken with regard to his property.

BUILDING TO CONTINUE

Contrary to many rumors in the Center that all educational construction work will be suspended in Rohwer, work on the high school auditorium is being done every day the weather permits, announced Tom Makino, resident architect. The foundation for the auditorium has been laid.

Construction work on the other high school buildings will be started as soon as possible.

The Evacuee Property office through its supervisors in the field where property is located and its representatives at the projects will conduct investigations, furnish information on request and advise the owners of property. Officials will act as intermediaries and negotiators between the owners and other persons when requested to do so but managers who actually operate properties are of the owner's own choosing.

The decision to accept or reject a given course of action, whether recommended by the Evacuee Property office or not, will rest with the owner. It is he who will decide whether his property should be leased or sold, whether goods should be stored or disposed of, whether a given price should be accepted or rejected.

It will, however, be the function of the Evacuee Property office to ascertain the facts and make available as many practical alternatives as possible, so that the evacuee in the Center may make a wise decision.

LAND ACT UNCONSTITUTIONAL

Attorney General Guy E. Williams held today that under the state constitution, Arkansas has no restrictions on land or other property ownership or its use by Japanese, Chinese or Indians, according to an article in the Arkansas Democrat.

The opinion concerning land or property ownership by Japanese conflicts with a 1943 act recently signed by Governor Adkins following passage by the 54th General Assembly that would prohibit Japanese from owning land or property in the state. It was written by Sen. B. Frank Williams, Osceola.

J. B. Bunn, assistant attorney general, who prepared the opinion, said he believed the Williams act could be voided because the state constitution can be amended only by a vote of the people.

Bunn said that Article 2, Section 20 of the constitution states that "no distinction shall ever be made by law between resident aliens and citizens in regard to the possession, enjoyment or descent of property."

He also called attention to a ruling by the Arkansas Supreme court in which justice Humphreys said in commenting on this part of the

constitution. "This section is peculiar to our constitution. It seems that other constitutions do not contain such provisions. The section contains few words and is unambiguous.

"The manifest and only intent which can be extracted from the language is that all residents alien in Arkansas, whether eligible to naturalization and citizenship under the laws of the United States, have the same right to acquire and enjoy the possession of property in this state, either by purchase or descent, that any natural citizen has."

Headed by Dr. Masaki Yayoshi, newly-elected chairman, the permanent executive committee is composed of Sadazo Uyematsu and Fred Koyama, vice chairman; Frank Mirikitani, treasurer; Juichi Fujimori, auditor; and Dorothy Kato and Mrs. T. Yamauchi, secretaries.

With its services open to all, the local chapter will be connected directly with the American National Red Cross, and the International Red Cross through which communications between warring nations are carried on.

The permanent chapter will hold its first meeting with the members, block representatives and all interested residents Monday at 7:30 p.m. in PS hall 20 to discuss the coming Red Cross membership drive.

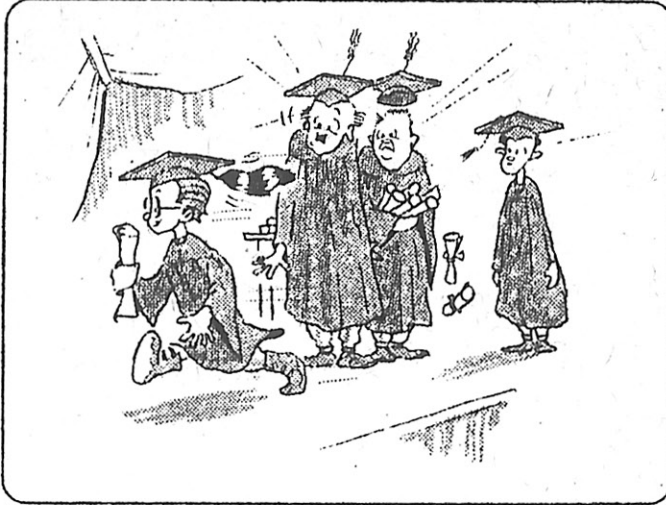

EDITORIAL FREEDOM'S LEADERS

America, the melting pot of the world, has not been devoid of minority problems though it has made progressive steps in trying to visualize the equality of men, no matter what their creed, color or race may be.

Upon the shores of these United States, people from many nations, with varied origins and countless beliefs have landed in the past few centuries -- each seeking to escape economic, social, religious or political pressure. The molding of America was based on free thought and free expression with democratic justice through the maxim that all persons are innocent until proven guilty.

Yet, in certain instances in American history, there have been times when the basic precepts of Americanism have been challenged. Such an instance was the Civil war.

Lincoln, our 16th president and the great emancipator, emerged during those troubled years and rewelded the ship of state into a seaworthy structure.

Today, again the keel on which our government was laid is afflicted, and there is danger that the vessel on which we ride will founder. Again, there is real need for leaders -- men who will forget the qualms of public opinion and who will strive to further their personal convictions.

Among today's leaders of democracy, Representative Vito Marcantonio of New York stands pre-eminent. For several years, he has attempted to bring about the existence of true equality by introducing legislative bills. His newest bill, H.R. 2011, proposes the amendment of the Nationality Act of 1940 and has been referred to the Committee on Immigration and Naturalization, according to the Japanese American Committee for Democracy.

"Be it enacted by the Senate and the House of Representatives of the United States of America in Congress assembled, that section 303 of the Nationality Act of 1940, approved October 14, 1940 (54 Stat. 1142, 8 U.S.C. 703), be, and hereby is, amended by striking out the said section and enacting a new section replacing it to read as follows: "THE RIGHT OF A PERSON TO BECOME A NATURALIZED CITIZEN OF THE UNITED STATES SHALL NOT BE DENIED OR ABRIDGED BECAUSE OF RACE, COLOR, CREED OR NATIONAL ORIGIN."

This Marcantonio bill would give the right to all Orientals to become naturalized citizens of the United States and would fit the Asiatic people into the national way of equality.
