

## STATEMENT ASKED BY MERIT BOARD RE: ALLOTMENTS

In view of the fact that financial allotments toward the granting of awards and leaves to deserving project workers were indefinite, the Merit Rating Board of the Unit I Community Council agreed to send a letter to W. Wade Head, Project Director requesting a definite statement regarding the issue.

Division heads are to submit names of workers eligible for the Honor Roll, from which the Merit Rating Board will weigh the merits of the individual and select candidates.

The question of whether WRA will bear maintenance and cost of trips granted was laid on the table until the next meeting, it was disclosed.

During Block Manager Supervisor George Nagano's absence, it was announced that John Kubota, block manager of 226 will act as a supervisor pro-tem.

## ALL WORK CORPS MEN ON \$16 WAGE BASIS

Project Director W. Wade Head yesterday approved the recommendation of the Manpower Commission to reduce the personnel of all project branches by July 10, and to place the entire Work Corps on a \$16 wage basis retroactive to July 1.

Head stressed that the reduction in personnel will be made as humanely as possible. Chief criterion for deciding who is to be retained will be the essentiality of an individual to Center operations.

## SCHOOLS MAY BE CENTRALIZED

Plans for a centralized school for the term '43-'44 were discussed at a meeting held last Monday, July 5, by the heads of the Education Division and the unit administrator Len Nelson.

The imperative need for centralized school grounds in Poston I has been indicated by an incident which took place recently in the western end of the Block 4 recreation hall when 7 chairs were broken beyond repair. During the school term when the furniture was under school supervision, not one chair was broken, but 5% of the chairs in Poston I have been broken at times.

Dr. Harris warned that if such incidents continue, the Poston students will again have to bring apple boxes to sit on as before.

It was pointed out that the 10% cut will be followed by other decreases which will reduce the over-all number of workers by 50% in the next three months.

Efforts will be made to raise certain key workers back to \$19 before the end of the month, and to make this classification effective for July. It was emphasized, however, that the number of workers in the \$16 category will not exceed 50%, or 10% of the Work Corps quota.

Manpower Commission will meet tomorrow afternoon for further discussion on this problem.

## QUOTA ON EASTBOUND TRAVEL LIFTED

W. Allen Cushman, acting head of the Department Station, announced today that the quota on the number of eastbound evacuees had been lifted. He indicated, however, that morning departures only were being made since money was not available at present to pay an escort who must accompany evacuees leaving in the evening.

Cushman reported that during the retransportation emergency on the Santa Fe when civilian travel was curtailed, the evacuees who left from Poston were successful in making connections, and experienced no major inconveniences.
