

AMPHITHEATRE STAGE TO BE REBUILT

The Unit III stage of the proposed civic amphitheatre is to be reconstructed with concrete foundation, according to Gerald Wumino, General Chairman for the construction of the Poston Square Garden.

The new plan, now being drawn up, calls for the building of additional rooms, under the platform for make-up and rehearsing. When the project is completed, it is to be equipped with a proper drainage system so as to avoid any similar destruction as that which was caused by the recent storm.

Work on the stage will be resumed as soon as the present flooded condition is remedied.

SEGREGATION TO BE ON BLOCK BY BLOCK BASIS

While the plans for moving of people from Poston to the Tule Lake center have not been fully worked out as yet, it was announced officially that it will be arranged on a block basis. Not all of the people will be moved at the same time. The repatriates and members of their families who will accompany them to the Tule Lake center will be the first group.

The "block by block" schedule will mean that people in that group will be assigned to trains and to particular seats by the blocks in which they reside at Poston. This is being done to bring about an orderly movement and to provide as well as possible for the comfort of all concerned.

The block by block plan will have the advantage of keeping the

LT. HOUSE RECRUITING NISEI GIRLS FOR WACS

Full of pep and enthusiasm, Lt. Roberta L. House, assistant district recruiting officer for the WACS, arrived in the Center again this week, her second visit since last March. This time she's here with the goods.

"When I came here before," she declared, "I could only give out information to the girls and arouse their interest. Now I'm ready to accept at least 75 applications from Poston.

To contact all girls in the center interested in joining the WACS,

Lt. House has arranged general meetings and personal interviews in each of the three units. "Bring your personal problems and questions to me," she urged, "and find out yourself what opportunities the Army gives."

Today she will interview in the Unit 2 administrator's office at 9 a.m. and then return to Unit 3 at 1:30 p.m. to finish up the interviews begun yesterday. Tomorrow she will be in Ralph Galvin's office in Unit 1 at 9 a.m. for appointments and interviews.

FULL TIME ESCORT APPOINTED

With the assignment of Mrs. Lucille Barrett as full-time escort, evening departures from the Center began again this week, W. Allen Cushman, head of the Departure Station, reported today.

Departures are scheduled 4 evenings next week, Monday to Thursday. The following week, when Mrs. Barrett escorts to Las Vegas, night departures will be made Monday, Tuesday, and Thursday only. This alternation of 4 and 3 night departures per week will continue until further notice, Cushman said.

THREE FIRES DISCOVERED IN UNIT 1

 speak tonight to Unit I girls in Mess Hall 32 at 8:30 o'clock.

The Lieutenant emphasized that this was an open enlistment, with no provisions made for a segregated unit. "I am here to take applications from you girls just as I would in Phoenix or New York from any other American girls," she said.

Nisei girls, she pointed out, will do the same type of work in the WACs as any other person in the corps. At present the main job is administrative work, which includes stenographic, clerical, and light technical duties.

Since her visit to Poston in March, the WAC officer stated that requirements have been lowered. Minimum qualifications now are: height, 4'8"; weight, 95 pounds; and age, 20.

In addition to meeting these requirements, an applicant must pass a mental alertness test, which will be held sometime Saturday. Definite time for the examination will be announced later, Lt. House said.

The Lieutenant indicated that she would be here until Saturday night, and expressed her desire to meet anyone interested. "I will be available to anyone for special interview," she said. "I would be glad to talk to parents as well as the girls."

Residents desiring to contact Lt. House anytime during her 3 day stay here may do so through Chief of Employment Gile's D. Zimmerman's office in Unit I, which will be constantly advised on her whereabouts.
