PLANS MADE FOR ABSENTEE VOTING

On the 25th of August, there will be held in the State of California a direct election for nomination of the following offices: Governor, Lt. Governor, Sec'y of State, Controller, Treasurer, Supt. of Public Instruction, Attorney General, Members of the State Board of Equalization, Representatives for Congress. Judges of the Superior Court, in counties where the terms expired, will also be nominated. A general election for such offices will be held November 3.

The Law Dept. is preparing a notice explaining the absentee voting in Arizona and California. The list of Candidates to be voted on in the primary election has been secured from the Sec'y of the State of California.

The candidates selected for state offices including the governor and legislature as well as the U.S. Congress may be inspected at the Law Dept., at Elk. 21-10-A.

"While the notice which will appear in the Press Bulletin within the next two weeks will answer some of the important questions, anyone interested can call at the Law Dept.," said Theodore H. Haas, of the Law Dept.

Each voter must make application 5 to 20 days before the August 25th and November 3rd election in order to get your ballot.
