FIRE DEPARTMENT ORGANIZATION TAKES FORM!

Thomas Nishimoto has been appointed Fire Chief of Poston. Following a general meeting of colonists, qualifications for members of the Fire Department were established, and a request for 20 men for this duty was made for assignments for the blocks. These men were divided into platoons and time of duty set. One man from each block has been designated as acting captain. Miss Etsuko Furuts has been selected as acting secretary with offices in the Administration Building.

A survey has been made of the fire hazards in Poston, and also the means available to reduce these hazards, and to extinguish any fire that may occur, with speed and efficiency.

An organization of the various blocks has been made. Firemen will bring the garden hose assigned to the block to the scene of the fire upon the sounding of a fire alarm. Fixed responsibilities for the assembling of hose have been designated to members of the Fire Department.

It was decided that all the shovels that could be assembled would be taken immediately to the scene of the fire, to be used in extinguishing the blaze. Instructions have been given to the various blocks in use of fire hose and shovels.
