## SAY DAMAGE CLAIM LOBBY IS FUTILE

Washington, D. C.—Rep. B. W. Gearhart and John Phillips of California warned the evacuees last week that heavy expenses to themselves and ultimate failure will result in their alleged plan to establish a lobby in Washington and press claims for \$400,000,000 in evacuation damages from the government, according to the Hearst newspaper's reporter, Ray Richards.

## "PREACHERS OF HATE" HIT BY ADJUTANT MARSHAL

New York City—Persons who stir up prejudice against Japanese-Americans were denounced as "preachers of hate" by the adjutant marshal in a letter recently received by Leo T. Simmons, acting relocation supervisor of the Middle Atlantic Area, from Adjutant Marshal G. Stamb of the American Legion's Captain Belvidere Brooks Post No. 450 in New York City.

A few weeks ago Adjutant Staub's invited to membership the Nisei soldiers whose names were removed by the Hood River, Ore., post from its county honor roll.

## Uphold Conviction Of Draft Evaders

Conviction of sixty-three Japanese-Americans in the United States district court in Wyoming for refusing to report for induction into military service was upheld Monday by the Tenth United States circuit court of appeals. They were sentenced by Judge T. Blake Kennedy to serve three years in the penitentiary.

The circuit court decision was handed down in the case of Shigeru Fujii and it had been stipulated by counsel on both sides that the opinion in this case should control all the others.

"Two wrongs do not make a right," Judge Walter A. Huxman, who wrote the circuit court of appeals opinion, said. He also pointed out that Fujii could have obtained his release from the Heart Mountain camp under a writ of habeas corpus and that since he has disobeyed a law of the United States he must pay the penalty.
