SEE CONFUSION IN REPATRIATION CASE

Winnipeg, Canada—There has been too much confusion taking place among Japanese evacuees regarding repatriation to those who seek repatriation, the New Canadian newspaper declared yesterday. Especially has this been true in the case of those who have signed forms requesting repatriation, yet who have intended to return to Japan after the war. They have been held by the immediate authorities pending to those who seek repatriation. The "advantage" included the promise that they would be permitted to remain in British Columbia until repatriation is arranged—work places may not ever take place.

"Now that the war has ended I believe the right place in American life with greater assurance than at any time in the past. The war has placed heavy burdens on the shoulders of all Americans who have assisted them in this vital state and a unparalleled opportunity to improve their lives in the United States and this opportunity has not been neglected."

New 44-hour work schedule, instead of the previous 48-hour week was announced today by Relocation Officer James Curtis. The office in the Midland Bank Bldg., therefore, will close at noon Saturdays.

WULEANS TAKE IT

Tule Lake, Cal.—The 17,000 evacuees at this center took the Nippon surrender offer quietly, said Asst. Relocation Officer Herb Ross yesterday. About 30 per cent of the inmates either are natives of Hiroshima or have relatives there. Those with relatives in Hiroshima took it for granted they were killed and held individual memorial rites. Some of the older people took the news pretty hard, Ross said, but some mistook the occasion to "tell off" their elders. He said repatriations would be handled by the Justice Department, which in any event, was expected to take over the center by the first of the year.

CIO Asks For Investigation of Race Tension

San Francisco—The CIO Council on Aug. 12 asked District Attorney E. G. Brown and State Atty. Gen. Robert Kenny to investigate "racial tensions" in San Francisco. The request, in the form of resolution, was signed by Pres. George Wilson. It cited one case concerning neighborhood business groups who took action against a returned Chinese American veteran who wished to buy a business and another involving a girl who was discharged from her employment because of "traits received by her employer."

Rise of Ku Klux Klan Groups

Fresno, Cal.—The Ku Klux Klan and similar groups are revived in California, particularly in the Los Angeles Area, it was charged here in a formal statement by the Joint Legislative Interim Committee on Un-American Activities. Investigation of the groups, some two score, was authorized. "The committee reaffirms its condemnation of all groups and organizations teaching advocating religious and racial intolerance," chairman of the group, Sen. J. R. Tenney, said, "and orders a public hearing at the earliest opportunity and to summon and subpoena all leaders and individuals engaged in activities creating racial antagonisms and religious intolerance."

San Francisco—Indictments by Federal Grand Jury in Sacramento Aug. 6 against James E. Watson and his brother, Claude Watson, in connection with the asserted terrorist activities against Sumio Doi and his family in their Auburn farm last Jan. 19. The State Department of Justice kept watch on the two nation. On April 17 the Watson brothers and two AWOL soldiers were brought to trial in Elmer County. The jury brought a verdict of acquittal. This is the first prosecution in this area under the Federal Explosives Act.
