On The Other Hand

- 1. That having exempted the nisei dentist from the exclusion orders which apply to all issei and nisei, the Army is excluding him under the individual exclusion procedure. This is the method which has been used against citizens of German and Italian extraction.

Niseis To Work At Army Ordnance Plant

Washington, D. C.—Niseis will help to produce munitions at their first employment to take place in the Army Ordnance Departments at Tooele, Utah, and Sioux, Nebraska depots, the War Department has announced.

"Only those of unquestioned background and loyalty will be chosen for employment by the representative of the Civilian Personnel Section of the Office of the Chief of Ordnance, Army Service Forces, who are now at several WRA Centers selecting qualified made workers from among those evacuees not eligible for military service. Entry of many men into the army as volunteers and inductees has reduced the pool of available male evacuee labor."

ENDOW, KOREMATSU CASES COMING BEFORE SUPREME COURT OCT. 10

Salt Lake City—JACL national headquarters announced that the Korematsu and Endo cases will be argued before the United States Supreme Court on October 10. The Korematsu case will test the constitutionality of the evacuation from the Pacific Coast and the Endo case will decide the extent of the authority of the WRA over the evacuated Japanese now in the relocation centers.

Firm Willing To Hire Isseis From Now On

Chicago—The John F. Cuneo Company, manufacturers of technical and school books in Chicago, has employed niseis for more than a year, but until recently was not able to offer employment to issei because of the nature of its contracts. They are now able to hire isseis without any prior clearance and offer employment to 25 issei men and women for light clean work in their Chicago plant.
