CITE NUMBER OF OWNERS OF LAND

Sixty-four issues and 84 niseis own farm lands in Colorado. Relocation Officer James H. Curtis of the local WRA office said yesterday before a conference of social workers at Shirley Savoy Hotel. Other statistics given by Curtis included these: 2,214 aliens and 5,772 niseis in this state. Total number of all persons of Japanese descent, represents 7,110 of 1% of the state's total population. Since Pearl Harbor, 2,342 evacuees have come to Colorado from the Pacific Coast and an additional 2,273 from WRA centers. There are 463 niseis from Colorado in the army.

Whether they are being influenced by Gov. Earl Warren, or whether other selected factors are influencing them in their decision is hard to guess, but a quick review over the California political trend by a Chicago newspaper man shows some significant nods toward the Republican party and Tom Dewey.

Some interest is shown in the dramatic switch made by State Sen. Jack B. Tenney from the Democratic to the Republican party. Tenney once took a hand in mulling over anti-Japanese issues, notably as chairman of the legislative committee investigating un-American activities.

The state's C.I.O., of course, is for F.D.R. A.F.L. is divided. Governor Warren in Chicago the other day charged that corrupt municipal political machines are rushing to Roosevelt's support. How much influence aging ex-Gov. Olson, state's veteran Democratic party leader will have upon the electors of the state, remains to be seen.

Ultimately, the state's preponderant choice for F.D.R. or Dewey, will be decided by Joe and John Voters who stop by the temporary voting booth in their neighbor's house before, or after work, to cast their ballots. It is they, rather than the station politicians and labor leaders, who will help to decide on the Presidential choice.

REPORT OPPONENT OF GIRL'S ENROLLMENT DROPPED OBJECTIONS

Pasadena, Cal. — While controversy last week swirled over her head and around her, Esther Takei herself was non-committal over an attempt made to remove her from enrollment at Pasadena Jr. College.

According to William C. Carr, Pasadena chairman of the Friends of the American Way which gained Army permission for her return to the Southland, she is not allowed to make a public statement regarding her position or feelings. Meanwhile, Carl Palmberg, student editor of the Chronicle, student newspaper, said that a poll by the student body leaders approve Miss Takei's presence at the school and that an editorial to that effect will appear in the Chronicle tomorrow.

George L. Kelley, who staged a one-man protest against Miss Takei's enrollment, subsequently withdrew his objections, according to reports. SAY PROPOSAL IS FASCISTIC

Highlight of the 3-day conference of the Fellowship of Reconciliation was a public mass meeting held in opposition to "Amendment No. 3, the Anti-Alien Amendment," Saturday evening at Grace Community Church. The F.O.R. is opposed to the Denver City Council, City Committee for Fair Play, and the integrated groups of the state. Dean Roberts and Rev. Weaver were the speakers.

"Amendment No. 3" is a proposal to prohibit aliens ineligible for U.S. citizenship from owning land in the state of Colorado. This amendment if enacted would apply directly to, among others, alien Japanese, Indian Americans, Filipinos, and Portuguese. One such move in this direction along the Pacific highway might possibly lead toward the taking of further steps to establish more strictly narrow nationalism, racism, and other platforms which divide the human family, the F.O.R. believes.
