### \$1,000 Reward to Bar Attacks On Nisei in Calif. Revealed

SACRAMENTO. — A standing reward of \$1,000 will be posted by the American Civil Liberties Union for the arrest and felony conviction of any person attacking a Japanese American in California.

This was disclosed by Attorney General Robert W. Kenny at a session of the one day conference of the California Councils of Civic Unity last week.

Kenny said the Civil Liberties Union has offered the reward as a means of curbing attacks against Japanese Americans who have been returned to the West Coast. California law does not permit the payment of such rewards by the State, Kenny declared.

Identify Is Secret  
The reward is to be paid for each case resulting in a felony conviction. The attorney general stated the identity of the person receiving the reward will not be revealed.

At the same time, Kenny told approximately 40 representatives of race relations groups from all parts of the state that the frequency of disturbances involving attacks on Japanese American in the state has subsided in recent weeks, and it is hoped the posting of the reward will discourage them entirely.

Frank A. Charvo, editor of the San Francisco "Examiner," who was the principal speaker at a luncheon session in the Elks Club, warned racial unity committees against the "danger" of overloading their membership with people who are super idealistic and sub practical.

Calls For Fairness  
Fairness and justice, said Charvo, are necessary to the successful conduct of such a group.

These racial unity committees are of utmost importance in any community where more than one race is working and living," Charvo declared. "They must be fair and just."

### Court Bans Commercial Leases By Alien Japanese

STOCKTON. — In an unprecedented ruling, Superior Judge Marion G. Woodward last week declared that alien Japanese do not have the right to lease and occupy commercial property in California.

The ruling was made in a suit brought by Emil Palermo, Stockton, against Stockton Theaters, Inc., an alien Japanese-controlled firm, to break a lease on a Stockton theater signed in 1942. Palermo's father, who died in 1942, leased the property to the Japanese.

At the time the lease was executed it was permissible under a treaty then existing between Japan and the United States. The treaty was abrogated in 1940 and since that time the lease was unlawful under the laws of California, Judge Woodward held.

### Nisei Plead Guilty To Service Evasion

Five Nisei youths who said they would not bear arms against any country, pleaded guilty to charges of draft evasion at an arraignment Saturday before U. S. Commissioner Oakes.

They were held in county jail in lieu of \$2,500 bonds. They are Archie Atsushi Amato, 21; Joe Kawamoto, 24, and three brothers, Harry, 21; Takao, 19, and George Kenichi Ishimoto, said their parents were born in Japan.

The parents did not influence their opinion on the war, they added. The three Ishimoto brothers have been operating a farm at La Salle since 1942.

They were born in Riverside, California and attended schools there. George was studying engineering at the University of California in Los Angeles at the time of the evacuation.

FBI agents arrested four of the youths after they failed to report for induction June 28 at Fort Lupton.

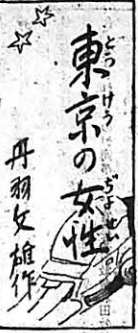
