"Japanese Evacuees in Arizona A Contented and Happy Group"

Ariz. Sacaton--The writer voices the opinion that, in general, the evacuees at Rivers are contented, and are being kept busy raising a variety of vegetables. ".....Arizonans, foreseeing a shortage of fresh vegetables, are hoping there will be some produce for sale in near-by cities such as Tucson and Phoenix. Next spring a substantial acreage will be planted to long-staple cotton required for military goods such as gliders and balloon cloth..." Ore. Klamath Falls (AP)--A committee is still investigating conditions at Tule Lake. "...Chairman Fred H. Calif. "...Harold Wilson, deputy State superintendent of banks, testified that a ten month search has failed to uncover orders, receipts, letters and other documents having to do with moneys of the N.Y.K. Steamship Lines on deposit in the Yokohama Specie Bank, Ltd...." A Korean translator is "seeking clues as to what has happened to the bulk of the more than \$50,000, believed by American creditors of the N.Y.K. Wash. D.C.
