SUMMARY

The volume of newspaper publicity about WRA continued heavy, with interest centering in the Senate Military Affairs subcommittee recommendations, the Heart Mountain strike and food situation, and in the Marengo, Illinois, employment incident. WRA was also the butt of considerable vociferous congressional criticism centered about the Denver Post disclosures and rumors that evacuees were to be returned to the Pacific Coast.

On May 7 the Senate Military Affairs Committee announced that it had approved in full the recommendations of its subcommittee headed by Senator Chandler. As reported in the press, these recommendations embodied the expected three-way segregation plan. AP described the plan as advocating "abolition" of the centers; whereas INS said that the committee had recommended "imprisonment of disloyal" Japanese.

Mountain states and Pacific coast papers paid a good deal of attention to the strike at Heart Mountain. Reports seemed to be factual with no attempt to distort one way or the other.

The Denver Post followed its series of muckracking feature articles on Heart Mountain, reviewed last week, with provocative editorials and day-by-day news reports of WRA's investigation. More serious than the original Carberry articles from a public relations point of view was the fact that the later stories were picked up by the wire services and used by papers across the country. Those Members of Congress who already lacked comprehension of the internal Japanese American situation were given a convenient peg upon which to hang demands for anti-Japanese legislation.

The following congressional investigating committees were reported to have shown concern about WRA's operations at Heart Mountain: Senate Committee Investigating the War Program (Truman committee); Dies Committee; Senate Military Affairs Committee.

The California congressional delegation was reported to have appointed an unofficial committee, headed by Rep. Costello, to protest to the war Department the issuance of Public Proclamation No. 17,

The proclamation seemed to be regarded as an entering wedge toward the return of evacuees generally to California.

Most heartening event reported in the week's press was the reinstatement of evacuee workers at Marengo, Illinois, who had been removed as a result of adverse community sentiment arising after the announcement of the Tokyo executions. At a town mas meeting, local citizens voted 60-21 to allow the Curtiss Candy Company to retain its evacuee employees.

From the Pacific Northwest it was reported that evacuee farm laborers are arriving in considerable numbers. A Farm Security press release predicted placement in that area of 1,050 by June 15.

Items in five southeastern papers described a trip to Camp Shelby of a group of nisei girls from the Arkansas centers. Tone was sympathetic.

Editorials were primarily interested in Mrs. Roosevelt's trip to Gila, the Heart Mountain situation, and WRA's regular re-employment program.

There is every indication of an organized campaign among West Coast pressure groups to re-enforce public sentiment in favor of General DeWitt's stand. Among the organizations reported to have passed resolutions last week were the Chambers of Commerce of the four largest coastal cities.

Governor Osborn of Arizona appointed a committee made up of businessmen to study the probable effects of allowing evacuees to remain in Arizona after the war, and Governor Aikins of Arkansas again stated that he would disapprove permanent relocation of any evacuees in his state.

Last month's clamor in the California press for the seizure of evacuee equip ment has quieted down, but the California legislature is still occupying itself with the matter.

Minidoka combat team volunteers were reported to have participated in an OWI short wave broadcast beamed at Tokyo.
