- 1. Inclosed for your information and file is copy of a petition submitted by certain Japanese residents of the Tulelake Center to the Honorable Henry L. Stimson, Secretary of War.
- 2. The signatures attached to this petition were all written in English and were transcribed by Civil Affairs Division's translators, who report that some of the names had to be reversed for uniformity.

Dear Hon. Stimson:

We, the duly elected representatives of the Tule Lake Center, W.R.A. at Newell. California appeal to you on the following concerns relative to the existing circumstances at Tule Lake Center, W.R.A. at Newell, California: Whether the administrators of the said center are operating the center above mentioned as per instructions of the W.R.A. was doubted in the minds of the local residents of the said center; therefore, in view of the aforementioned the representatives of the said center commenced an immediate negotiation with the administrators of the said center; and in due process of negotiation thereat arrived Mr. Dillon Myers, Director of the W.R.A., who made certain promises to the requests of the representatives of the center. The said representatives at which time agreed to take an amicable course with the said administrators so long as those various agreements were fulfilled by the proper authorities. Whereas, and in view of these agreements, the said administration proceeded to violate the provisions of the said agreement; and therefore, the residents hereat diversified their attitude. At this time the said representatives selected a committee of fourteen in order to negotiate further with the said administrators requesting for the bare essentials of livelihood; thereupon, Mr. Best, Director of said center, as to the aforementioned, in reply, declared that it is beyond possiblities to operate the said center on the basis of these requests; and soon thereafter the said Mr. Best placed into the hand of the military authorities his authority to control the said center. The said representiatives avowed that they will offer their utmost co-operation to whomever it may be, the

military authorities or the W.R.A., and once again in order to reach an amicable conclusion the negotiating committee approached the military officials as the said center by this time was under the military control; and at which time the said military officials considered the negotiating committee to be the representatives of a mere small fraction of the total populace of the said center; furthermore, the said negotiating committee were considered to be a mere political organization and instigators; thereby, the said military officials refused to negotiate with the said negotiating committee; and moreover, the military authorities took into custody not only the members of the said negotiating committee but aside from the said negotiating committee two hundred members or thereabouts of the local residents who have not a charge of offenses against them are also under military custody. Because of the refusal of the military authorities to recognize the said negotiating committee the local residents of the said center have signed resolutions twice thereupon signifying that the said negotaiting committee is a true and entrusted delegate of the said residents of the said center.

We, the representatives, are desirous of informing you of the developments of the existing circumstances thereof; and that we are consenting to offer utmost co-operation in the early settlement of the matter; and therefore, if the military authorities do not recognize the disposition of the said negotiating committee we cannot but help maintaining status quo. Therefore, and furthermore, we submit to you the above mentioned information for your discernment in order that we may request assistance relative to bringing this matter to a successful conclusion.
