SUBJECT: Clothing Allowances

In response to your memorandum of January 21, 1943, a review of all individuals and families transferred to Minidoka was made, and we are attaching a list showing the amount of their clothing allowances which have been or will be mailed to them, depending upon the month in which they are eligible. We have followed the policy of mailing clothing allowance checks to all individuals or families who earned the allowance at this project and have since been relocated or transferred. We feel that this is the correct policy to follow.

This, of course, did not include the clothing allowance that is paid due to eligibility for public assistance grant since their eligibility will depend upon an investigation by the Social Welfare Department at the project where they are residing.
