



We, the undersigned, citizens of the United States of America, and of the State of Washington, in order to encourage friendly intercourse, promote the intellectual and cultural advancement, and by organized effort to ameliorate ourselves and our posterity to the highest standard of citizenship, do hereby assoiate ourselves in this league, and pledge to be governed by the following rules:

#### CONSTITUTION

The name of this league shall be the Valley Civic League.

#### ARTICLE II

The office of this league shall be in the city of King County, State of Washington.

Membership of this league shall be composed of those Japanese born within the United States and its territories, Who have attained the age of eighteen years and who reside in that district known as the White River Valley.

(a) ACTIVE MEMBERS-those, who have attained the legal age of 21 years, shall have the right to vote upon all issues and shall have the right to hold office in this organization.

(b) ASSOCIATE MEMBERS-those, who have not attained the legal age but are between the ages of 18 and 21, who shall have the right to participate in all the meetings and activities of the league except the right to hold office and to vote.

#### "OATH OF ALLEGIANCE"

"I pledge allegiance to the United States of America and promise my fealty to the Valley Civic League, to use every effort to promote the welfare of our Republic, to uphold the principles of Liberty and Justice, and to work for the upbuilding of our community."

There shall be the following officers elected for a term of one year by the regular members at the regular meeting in September of each year to-wit: PRESIDENT, SECRETARY, TREASURER.

ARTICLE VI It shall be the duty of the President to preside at the meetings of the league, to preserve order therein, to sign all official documents, to appoint all committees not otherwise provided for, and perform all other business which may by right pertain to his office. (b) SECRETARY. It shall be the duty of the Secretary to keep record of membership and of the minutes of all proceedings of the league. He shall be the keeper of the seal of the league and attach the same to all official documents; he shall promptly attend to all communications received by the league, and other incidental business pertaining to his office. He shall perform the duties of the President in his absence. (c) TREASURER. The Treasurer shall have charge of the financial concerns of the league. ARTICLE VII The regular meeting of this league shall be called on the first Tuesday in March, June, September, and December of each year. ARTICLE VIII Each member of the league shall pay to the Treasurer the annual membership fee of one dollar, at such date as may be prescribed by the Treasurer of the league. ARTICLE IX These articles and provisions may be repealed, added to, or amended by a two thirds vote of the meeting, at any meeting duly called. Provided, that notice of such proposed repeal, addition to, or amendment of these articles shall be given in the call for such meetin. FIRST MEETING OF THE VALLEY CIVIC LEAGUE,

September 15, 1930

The first meeting of the Valley Civic League was held at the Community Hall at Thomas, Washington, on the 15th day of September, 1930.

The meeting was opened by a general discussion on political subjects, Mr. H. K. Fukuhara, of Auburn, acting as temporary chairman. Mr. Fukuhara opened with a brief speech.

Mr. M. Terada was appointed chairman for the evening, and Mr. Thomas Iseri, secretary.

A brief talk as to the object of this League was given by Mr. James Sakamoto, of Seattle.

The Constitution of the Seattle Progressive Citizens' League was thenread and explained by Mr. George Ishihara, of Seattle.

Discussion as to the age at which Associated Members be admitted to the League was brought up. A motion was made to admit those who would attain the age of 18 before the first of January, 1931, although they would not be entitled to vote until they were 21. Motion seconded and carried.

The matter of the name of the League was then brought up, and the following suggestions were given; Valley Civic League and Valley Citizens' League. A motion was made that it be called the Valley Civic League. Motion seconded and carried.

The matter of officers was then brought up. Motion was made and seconded that we have three officers, President, Secretary and Treasurer, and a nomination committee, which was to nominate as the Vice President or Vice Presidents, and electing as many/is needed for the best interest of the League.

The question of regular meetings was then brought up by
Mr. Ishihara. Motion was made and seconded that the meetings

## V. C. L. BANQUET TONIGHT WILL OPEN NEW POLITIC LIFE

Organization, Outgrowth of Citizens Convention, Inaugurates
Era Of Political Consciousness; Civic Leaders To Speak

#### TAKAYOSHI WILL SING

AUBURN, Wash.—The newly organized Valley Civic League, as an outgrowth of the Japanese-American Citizens convention held in Scattle recently, is to get under way with an inaugural banquet this evening at the local Chamber of Commerce from 6:30 p. m. when Sen. Lunn, 30th state senatorial district, and Mayor McKee of this city will participate in the inaugural ceremonies for this organization to stimulate a proper political interest among American voters of Japanese ancestry in this valley.

It is a significant fact that a political consciousness has been awakened among Americans of Japanese ancestry in this valley district, which is being taken as an augury of the day when these young people will take the place of their parents and become a contributing factor in the civic life of their respective communities and sections.

#### Consciousness Growing

This political consciousness seems to have been aroused since the Seattle convention and has been in the ascendancy with definite and practical turn in the formation of the Valley Civic League nearly three weeks ago at Thomas.

As its first president, the 16 charter members elected John Arima, a University of Washington graduate to assume the executive office, with George Yasumura as secretary and Fred Okimoto, of Kent as treasurer.

The two vice-presidents were elected later and have been the first of the women to join the organization. They were Mary Maeda, first vice-president, Kent, and Fumi Yamanaka, second vice-president, Christopher.

#### Interest Well Laid

The interest in this citizens' movement has been well laid by these officers and charter members, and the propitious moment taken to sponsor this league is indicated in the figures compiled for three of the main townships in the Valley. It is estimated that there are some 441 Americans of Japanese ancestry in the three towns of O'Brien Orillia and Kent, of whom 235 are men and 206 women.

Of tihs number 61 and more are at or above high school age, while 209 and more are of grammar school age. If the Thomas section and this city, together with Algona and other towns, are taken into consideration, the number of American-born Japanese might be placed at more than 600, of which number more than 100 would be of voting age.

The start made by the Valley Civic League is being heralded in all near-by centers as a good one, painting an optimistic picture of second generation activity in the civic life of their respective communities.

#### Unity Sought

The inaugural banquet this evening is intended to bring the citizens of Japanese ancestry into closer unity in the stimulation of greater political interest that their participation in the political life of their district may be assured.

For this reason Sen. Lunn who remains unopposed in his district for the state senate, is to be the principal speaker, and it is believed that in his address he will point out the necessity of living up to the rights held by American citizens. Mayor McKee is to open this banquet with an address of welcome, as he will also administer the oath of allegiance and pledge to the members of the League.

The affair is to be a big one and besides the members of the new league, representatives from the various sections are also expected to attend. Among the guests for the evening will be the officers of the Seattle Progressive Citizens League. Clarence T. Arai, president of the Seattle league, will be one of the speakers while Ashley E. Holden, of Seattle will also be a speaker on the program.

Welly Shibata will be on hand with a surprise up his sleeve, while Tomeu Takayoshi will sing several songs.

THOMAS Wash. - Preparations are now under way to launch the Valley Civic League when this citizens organization for Americans of Japanese ancestry holds forth in its inaugural banquet at the Auburn Chamber of Commerce on Saturday, October 4, from 6:30 p. m.

More than 100 names have already been affixed to the roster of this League which was organized by the representatives from various sections two weeks ago. The coming affair is to launch the citizens' movement in the valley district, and in order to help stimulate the proper interest in the organization, Senator Lunn from this district to the state legislature is to be requested to parti cipate at the banquet as the principal speaker.

Mayor McKee of Auburn will, undoubedly, make the welcome address and administer the oath of allegiance and pledge to the League for

the organization.

League Strong This new citizens league is well founded and its membership is drawn chiefly from Thomas, Auburn Kent, O'Brien, Orillia and Algona. Other eligible members are beginning to come to the call of the League and in time it is expected to be one of the largest organizations of its kind in the Northwest.

Two weeks ago the League started out with its 15 charter members, but within a week more than 60 members had joined the new chapter of the Japanese-American Citizens League which recently held its convention in a highly sulcessful manner in Seattle.

The banquet to be held next Saturday is to be a big affair and besides calling the mayor of Auburn to make the opening and welcome address and Sen. Lunn to give the principal address of the evening, Clarence T. Arai, president of the Seattle Citizens League, and Ashley E. Holden are also to be on the speakers list.

Japanese Speaker One Japanese speaker, who is to be selected from among the prominent residents of the valley district is also to be called on to address the banquet. As plans are at present an impressive ceremony is booked for impressive ceremny is booked for the members when they take their oath of allegianec and pledge their loyalty to the League.

Various Seattle people are to be invited to this gathering, and among them are to be the officers of the Seattle Progressive Citizens League. The others will be prominent Seattle newspaper publishers, organization heads, pioneers and business men.

Tomeu Takayoshi, prominent Northwest second generation vocalist, is also to be on the bill, and he will be supported by some local talent.

The banquet will probably be opened by the program chairman Terada and after the opening numbers the meeting is to be turned over to John Arima, president of the League. 
