Forming of a Boy Scout Troupe has been discussed. This being a character building organization with no racial discrimination it was voted to be taken up. Scout masters to be chosen at the coming meeting. Age limit is up to eighteen years of age.

Transportation for league members.-- Members with cars to round up his neighbor members without transportation to each league meetings.

Membership social to be in a banquet form with the losing sides in the drive to be hosts. American Legion Hall and the Fraternity Hall has been suggested for place.

To make it possible for inviting the Nat'l. officers, a joint-installation has been suggested.

The corresponding secretary was asked by the President to send word of appreciation to Mr. Sakuma for Mr. Tamotsu Murayama's lecture publicity.

At the end of each meeting, suggestion has been made to hold a quiz test. Have each member submit both question and answer on piece of paper, draw and question various members.

As there was no further business the meeting wa adjourned.

Both of the speakers stressed the importance of the work the Boy Scouts are performing, & the good derived from said work.

SEVENTY-SEVENTH MEETING
VALLEY CIVIC LEAGUE

March 10, 1939

The meeting was called to order by the president, Charles Toshi.

Minutes of the previous meeting were read and approved.

Report given by George Terada on the Murayama lecture. Out of the fourteen dollars and ten cents (\$14.10) contribution, ten dollars (\$10.00) was given to Mr. Murayama by the league. Five dollars (\$5.00) for hall. Deficit of ninety cents (90¢).

New members were introduced. They were as follows: Jim Kuranishi, George Hori, George Ikuta, Ed Fujii, Yukiye Ikuta, Frank Nakanishi, George Taketa, Pete Taketa, Takeo Hattori, Mary Tsuji, Yoshiko Tsuji, Shizuo Nishimura, Jack Arima, and Frank Arima.

Discussion on the membership drive was held. Nat'l Headquarter extended our drive to March 31st. A motion was made and carried that four points will be awarded all new members who have paid their dues by the 31st and are present at the meeting--two points if not present. If the old paid-up members are present, they will be awarded with two points each, if not present one point.

Ray Hattori, Assistant Scout Master of the Thomas Troupe, and Frank Naikanishi, Scout Master of the Taylor Troupe, spoke on Boy Scouts. This organization is composed of boys of all nationalities, their age ranging from twelve to eighteen years old. It is a character building organization, with no religion connected with it except that each boy have reverence to a god. These troops are sponsored by such organizations as churches, schools, civic bodies and other welfare clubs. Each troupe is to have three to five committeemen who must be able to attend the scout meetings and be of general help.

A motion was made and carried to have the President choose a committeemen of five or more and get started immediately. Those chosen as Troupe Committeemen were as follows: Mr. R. H. Fergin, Thomas Iseri, Mr. Frank Jensen, George Terada, George Yasumura, Tomio Itabashi, Gordon Hirabayashi, and Charles Toshi.

Women's Activities were discussed. A motion was made and carried that we form a Women's Committee. Mrs. George Yasumura was appointed by the President.

A report from Headquarter Sect'y that we form a Historian. Ethel Maebori has been appointed by the President. Duties of the Historian are to make collection of newspaper clippings of

activity of the Chapter--place in scrap book for future use.

A report on the monthly board meeting held in Seattle on February 19, was given by Thomas Iseri. Balance in the Nat'l ^{Northwest} treasury \$180.00. Stressed on emergency fund for legislative work to fight various discriminatory bills, addition of Historian for the Chapter, extension of the membership drive, forming of a Legislative fund Committee by appointment. Mamoru Wakasugi of Portland was re-elected chairman, Takeo Nogaki, Seattle chapter president as secretary, and Thomas Iseri, Council delegate from White River, as treasurer.

President requested all members to assemble by 8:30 p.m. at league meetings.

Thomas Iseri was appointed by the President to conduct all quiz contest of which all members will participate.

No further business; meeting adjourned.
