

TWENTY-SIXTH MEETING
VALLEY CIVIC LEAGUE

March 16, 1934

The meeting was called to order by president, Thomas Iseri. The minutes of the previous meeting were read, a correction to the minutes was made, correction being the appropriation of three dollars to be made by the Northwest Council Board for membership drive to each chapter instead of each chapter making the appropriation.

The report was made on the Northwest District Board which met at Yakima on March 10. The Idaho Young People want to form a chapter but since there membership is below the specified twenty-five, they will be known as the Idaho Young Peoples and will be connected with the Northwest Board. The Hood River Citizens have been conducting their meetings, etc., without being admitted to the board, so Saburo Nishimura was instructed to write a letter asking them to submit their intention of becoming a chapter; so that the board can act upon it at their next meeting.

A suggestion was made about having Ping Pong tournament and have the finals at the dance.

Motion was made and seconded that we have the Ping Pong

tournament. Motion carried.

After much discussion a vote was again taken, it was opposed. James Yasumura withdrew this motion and the tournament was indefinitely postponed.

Discussion was made about having a Citizen's Council here, like the ones in Seattle, Portland and Yakima, which is like the Northwest delegates only of the local heads of different organization with the League vice president as chairman, meeting four times a year, with four executive heads, political, vocational and social.


The next Northwest Council Board is to be at Tacoma on April 7, but if Fife has the Basket Social, they might hold it at our dance.

Various discussions and suggestions were made again in regard to the dance.


A motion was made and seconded that the committee take care of the prices of the orchestra, etc., motion carried.
