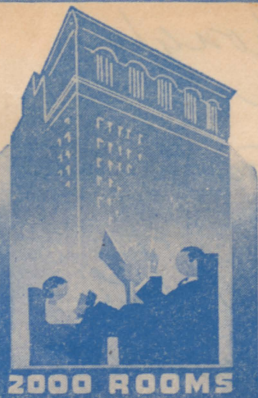

My boss and the employees were glad that I came back. During lunch hour they all treated me ~~to~~ with beer and

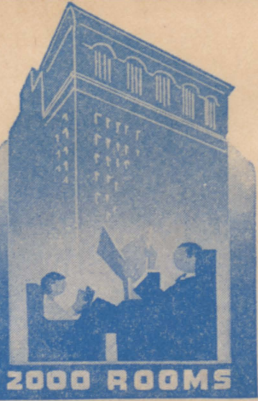


We had a swell time, although
