APPLICATION FOR REFUND OF MOTOR FUEL TAX

Rules and Regulations

Relating to Gasoline Tax Refunds

CLAIMS WILL BE CONSIDERED ONLY

1. When claimant has a permit and permit number is entered in upper right hand corner of form. Permits cost 50¢ and are good until March 31st following date of issue. Your first claim may accompany application for permit.
2. When filed on this authorized claim blank.
3. When received in office of Director of Licenses in Olympia not later than 5:00 o'clock in the afternoon of the sixtieth (60th) day following the date of purchase of the motor vehicle fuel.
4. When number of gallons of gasoline used in each kind of equipment is listed.
5. When signed, sworn to and sealed before a Notary Public.
6. When accompanied by original invoices given purchaser at time of sale. Invoices must show:
  - (a) Date of purchase.
  - (b) Name and address of both buyer and seller.
  - (c) Where gasoline was delivered.
  - (d) Number of gallons of gasoline written in both words and figures.
  - (e) Must show that State of Washington tax has been paid, or has been assumed by an authorized distributor.
  - (f) Must have no alterations or erasures.

IF YOU LOSE YOUR ORIGINAL INVOICE RECEIVED AT THE TIME OF PURCHASE THERE IS NO POSSIBLE WAY PROVIDED BY LAW FOR THE STATE TO MAKE REFUNDS ON YOUR CLAIMS.

NOTE: If you are in doubt regarding the filing of this claim or anything pertaining to same we suggest that you write to the Department of Licenses, Gas Refund Division, Olympia, for any information required.
