PURCHASE AGREEMENT
AN ENDOWMENT CARE INTERMENT PROPERTY

Subject to the conditions and covenants stated herein and on the reverse side hereof, all of which are expressly made a part of this agreement, CHAPEL OF THE CHIMES, a California corporation, hereinafter called "CHAPEL OF THE CHIMES" hereby agrees to sell, and

hereinafter called the "Purchaser" or "Buyer," hereby agrees to purchase interment rights in CHAPEL OF THE CHIMES in space as per plat on file in the office of CHAPEL OF THE CHIMES together with other items herein, as follows:

MEMORIAL LOCATION: (Grave - Crypt - Niche Capacity limited to persons)

Form with multiple sections for pricing: Space (Grave) (Crypt) (Niche), Credit, Endowment Care Fund Deposit-Property, Recording Fee, Interment Charge, Vault/Liner, Urn, Vase, Memorial Tablet, Endowment Care Fund Deposit-Memorial, Memorial Setting Fee, Cast Letters or Engraving, Niche Plate or Crypt Bar, Cremation, Cremation Container & Packaging-Pickup Shipment, Emblem, Sat., Sun., or Holiday Service, Total Sales Tax, Total Cash Price.

Form with multiple sections for pricing: 1. Cash Price, 2. Credit, 3. Cash Down Payment, 4. Balance of Down Payment, 5. AMOUNT FINANCED, 6. FINANCE CHARGE, 7. TOTAL OF PAYMENTS, 8. TOTAL SALE PRICE, 9. ANNUAL PERCENTAGE RATE.

To pay the TOTAL OF PAYMENTS set forth above in monthly installments of \$ the first installment being payable on and all subsequent installments on the same day of each month. The finance charge applies from No finance charge (interest) will be made if the full amount of the unpaid balance of the cash price is paid within 30 days from the date of purchase. Any refund of unearned interest will be computed by the rule of 78's.

As security for payment and performance of Purchaser's obligation, CHAPEL OF THE CHIMES retains the right to cancel this contract in case of default by Purchaser and repossess the interment space and any personal property purchased under the terms and conditions of this Agreement, including those terms and conditions set forth on the reverse side hereof.

NOTICE TO BUYER: (1) Do not sign this agreement before you read it or if it contains any blank spaces to be filled in. (2) You are entitled to a completely filled-in copy of this agreement. (3) You can prepay the full amount due under this agreement at any time and obtain a partial refund of the finance charge if it is \$1 or more. Because of the way the amount of this refund will be figured, the time when you prepay could increase the ultimate cost of credit under this agreement. (4) If you desire to pay off in advance the full amount due, the amount of the refund you are entitled to, if any, will be furnished upon request.

You, the purchaser, may cancel this transaction at any time prior to midnight of the fifth calendar day after the date of this transaction, provided no interment or substantial service or merchandise has been provided hereunder. To cancel, deliver or mail written notice of your intent to CHAPEL OF THE CHIMES, 32992 MISSION BLVD., HAYWARD, CA 94544.

Purchaser shall pay to CHAPEL OF THE CHIMES, on demand, a delinquency charge on any payment in default for ten (10) days or more in an amount equal to five percent (5%) of such payment except that such charge shall not exceed Five Dollars (\$5.00) or be less than One Dollar (\$1.00).

This agreement shall become effective only when signed by the Purchaser and when accepted by CHAPEL OF THE CHIMES.
