Dear Larry:

I hope no one has released to you any publicity about our efforts in connection with the New Jersey evacues situation, for I think any account of it now in PC or elsewhere would only strengthen the opposition into swift action.

We called together 20-30 orgs. in our general field last Honday to see what we could do to activate our New Jersey members and to pool our influence in the state. Mr. Lewis and I worked out the letter I enclose, got the statement from the TRA, added the editorials, and thought we had a positive program to advocate for the rest of the orgs. to follow. This material will not go out as is, however, for the New Jersey (codwill Commission, a State body, doesn't dare stick its neck out to act as a clearing house for us. Instead of the return card we had contemplated, which we had made sound very innocuous simply because it is pretty public property in the mails, we will have to urge our people to write the Commission to urge them to act. If they get enough pressure of this kind, they can go to Covernor Edge with it and say -- "Look here, we've got to do something." I wanted terribly to find a central non-sectarian body like the Commission to pool our names through-feeling very deeply that one of the main troubles with all of us decent people is that we are so unorganized.

Anyhow, since the Goodwill Commission is not joing to be the center of strength we had hoped, we are setting up a state action committee, to work until the Commission is empowered to act. Each org. represented here is asking one of its Jersey members to meet at lunch in Newark the 15th of May for this purpose. This, then, will be a purely Jersey body, but with tie-ins to us in the national offices so that we can watch how it works and work with it. They may appoint a committee at once to wait upon Covernor Edge, for instance. The legislature does not meet in regular session again until January. (There is to be a special session in May, but this may only take up the special legislation it was called into being forsomething about firemen's pay, etc. ) This gives us some time to do ed. work. Incidentally, it would have been a pile easier to sway public sentiment on the Great Meadows business if at least one of the guys had been a citizen; it was the weakness of the case. The Legion was distributing the Lechner "Playing With Dynamite" the week after the Great Meadows thing occurred, so a fight is undoubtedly in the offing, and your guess is as good as mine as to who is behind it.

You will see why I don't want publicity on this. The big boys would instantly go to work and they are better organized than the forces of goodwill.
