TEXT OF TESTIMONY TO BE DELIVERED BEFORE THE COMMISSION ON WARTIME RELOCATION AND INTERNMENT OF CIVILIANS, AUGUST 4, 1981, ON BEHALF OF THE LITTLE TOKYO SERVICE CENTER (LTSC)

- MY NAME IS MIKE MURASE.
- I AM THE PRESIDENT OF THE LITTLE TOKYO SERVICE CENTER, WHICH IS A FEDERATION OF THIRTEEN OF THE MAIN SOCIAL SERVICE ORGANIZATIONS SERVING THE JAPANESE AMERICAN COMMUNITY IN SOUTHERN CALIFORNIA.
- MEMBER ORGANIZATIONS OF OUR UMBRELLA AGENCY INCLUDE . . .
  - THE ASIAN AMERICAN VOLUNTARY ACTION CENTER
  - COUNSELING SERVICES FOR ASIAN AMERICANS
  - THE JAPANESE AMERICAN BAR ASSOCIATION
  - JAPANESE AMERICAN COMMUNITY SERVICES
  - JAPANESE AMERICAN CULTURAL & COMMUNITY CENTER
  - JAPANESE CHAMBER SOCIAL SERVICES
  - JAPANESE COMMUNITY PIONEER CENTER
  - JAPANESE WELFARE RIGHTS ORGANIZATION
  - LITTLE TOKYO PEOPLE'S RIGHTS ORGANIZATION
  - MARYKNOLL CATHOLIC MISSION
  - ORIENTAL BUILDERS ASSOCIATION
  - SOUTHERN CALIFORNIA SOCIETY FOR THE JAPANESE BLIND
  - AND UNION CHURCH OF LOS ANGELES.
- AS YOU CAN SEE JUST FROM THE NAMES, THE SERVICE CENTER IS COMPRISED OF GROUPS WITH A WIDE RANGE OF VIEWPOINTS AND AN EVEN WIDER ARRAY OF PROGRAMS AND ACTIVITIES, AND I CANNOT CLAIM TO SPEAK FOR EACH OF THE SEPARATE ORGANIZATIONS.

- I CAN SAY, HOWEVER, THAT THROUGH OUR WORK IN PROVIDING DIRECT SOCIAL SERVICES, LEGAL AND MENTAL HEALTH COUNSELING, INFORMATION AND REFERRAL, AND OTHER TYPES OF ASSISTANCE, WE HAVE COME TO UNDERSTAND VERY CONCRETELY THE GREAT IMPACT THE WORLD WAR II CAMP EXPERIENCE HAD ON OUR COMMUNITY.
- EXPERIENCE PERSONALLY, MY TEN YEARS OF ASSOCIATION WITH VARIOUS SOCIAL SERVICE, LEGAL COUNSELING AND COMMUNITY ANTI-CRIME PROGRAMS HAVE LED ME TO CONCLUDE THAT VIRTUALLY EVERY JAPANESE IN AMERICA WAS DEEPLY AND IRREPARABLY AFFECTED BY THE CONCENTRATION CAMP EXPERIENCE.
- I BELIEVE THAT FOR EVERY PERSON WHO COMES BEFORE YOU TO TESTIFY, THERE ARE HUNDREDS OF OTHERS, WHOSE STORIES WILL NEVER BE TOLD PUBLICLY.
- OF COURSE, AFTER SOME FORTY YEARS, MANY OF THE ISSEIS ARE GONE . . . AND OTHERS ARE TOO FRAIL TO COME BEFORE YOU NOW.
- THERE ARE OTHERS, WHO, TO THIS VERY DAY, FIND IT TOO PAINFUL
  TO SPEAK. . OF THE FOUR YEARS OF SUFFERING, AND THE FORTY
  YEARS OF TRYING TO FORGET, YET STILL REMEMBERING.
  - THERE IS A WOMAN, WHO FINDS IT TOO DIFFICULT TO RECALL THE EXPRESSION ON HER HUSBAND'S FACE AS HE WAS BEING DRAGGED AWAY BY THE F.B.I.--THE FACE SHE SAW FOR THE VERY LAST TIME BEFORE HE DIED A YEAR LATER WHILE THEY WERE STILL SEPARATED IN TWO DISTANT LOCATIONS.
  - THERE IS A MAN, WHO CAN ONLY SPEAK IN BITTER AND ANGRY
    TONES BECAUSE HIS EDUCATION WAS INTERRUPTED IN THE PRIME
    OF LIFE, AND HIS FAMILY'S BUSINESS WAS DESTROYED.

- THERE IS ANOTHER WOMAN, WHO SUFFERS FROM HIGH BLOOD PRESSURE, NERVOUSNESS AND OTHER ILLNESSES, WHICH WERE CAUSED BY THOSE STRESSFUL YEARS IN CAMP, AND FOR WHICH SHE ALONE BEARS THE BURDEN OF NEVER-ENDING HIGH COST OF MEDICAL CARE.
- THERE IS STILL ANOTHER WOMAN, WHOSE LIPS CANNOT FORM
  THE WORDS TO DESCRIBE THE FEAR AND THE SENSE OF SHAME
  SHE FELT WHEN SHE WAS PHYSICALLY ATTACKED AND SEXUALLY
  ABUSED BY SOLDIERS ESCORTING HER ON THE TRAIN TAKING
  THEM TO CAMP.
- THERE IS A MAN, WHO CANNOT OVERCOME HIS FEELINGS OF FUTILITY AND A TOTAL LOSS OF FAITH AFTER HE WAS FORCED TO SELL HIS FARM AND ALL HIS BELONGINGS FOR A FRACTION OF THEIR ACTUAL VALUE. HE IS A BROKEN AND DEFEATED MAN . . . A SEVERELY DEPRESSED ALCOHOLIC WITH NO SENSE OF SELF-WORTH.
- I ACKNOWLEDGE THAT NOT EVERY PROBLEM OR HUMAN SUFFERING
  THAT OUR SOCIAL SERVICE PROGRAMS DEAL WITH ARE DIRECTLY
  ATTRIBUTABLE TO THE EXPERIENCE OF THE WAR YEARS.
- YET, IT IS MY PERSONAL BELIEF, AND THE BELIEF OF THE STAFF
  OF THE LITTLE TOKYO SERVICE CENTER, THAT THE FAR-REACHING
  AND LONG-LASTING ECONOMIC, PHYSICAL, EMOTIONAL AND PSYCHOLOGICAL EFFECTS OF THE CONCENTRATION CAMPS, NOT ONLY
  REMAIN TODAY, BUT WE ARE LEARNING THAT SOME OF THE
  DEEP-SEATED PSYCHIC WOUNDS AND FEELINGS OF OUTRAGE, THAT
  HAVE BEEN SUPPRESSED FOR SO LONG, ARE JUST BEGINNING TO
  SURFACE.

- THE INSIDIOUS NATURE OF THE WARTIME STRATEGY TO DISPERSE

  AND FORCIBLY ASSIMILATE JAPANESE PEOPLE IN AMERICA BECOMES

  MORE EVIDENT AS WE LOOK AT THE IMPACT THE CAMP EXPERIENCE

  HAS HAD ON SUCCEEDING GENERATIONS OF JAPANESE AMERICANS ...

  TO SANSEIS AND YONSEIS WHO WERE NOT YET BORN IN THE 1940s.
- I HAVE HEARD THAT IN THE POST-WAR RESETTLEMENT YEARS, TREMENDOUS PRESSURES WERE APPLIED BY CAMP AUTHORITIES AS PEOPLE
  WERE RELEASED TO "PROVE LOYALTY" AND TO "DEVELOP AMERICAN
  HABITS." THE CLEAR MESSAGE WAS: DON'T BE CLANNISH AND
  DON'T BE SO JAPANESE.
- IN THE LATE FIFTIES, WHEN I WAS ABOUT TWELVE YEARS OLD, I HAD A FRIEND WHO USED THROW AWAY THE RICE-BALLS HIS MOTHER PACKED IN HIS SACK AND SKIP LUNCH WHILE HIS FRIENDS ATE SANDWICHES.
- ANOTHER FRIEND IMPLORED HIS FATHER TO LET HIM OFF A COUPLE
  OF BLOCKS AWAY FROM SCHOOL EVERY MORNING BECAUSE HE WAS TOO
  ASHAMED TO BE SEEN BEING DROPPED OFF FROM A GARDENER'S TRUCK.
- THE SERIOUS EROSION OF OUR DIGNITY AND PRIDE AS
  A PEOPLE IS ALSO MANIFESTED IN SUCH PHENOMENON AS
  THE UNUSUALLY HIGH RATE OF INTERMARRIAGE AMONG SANSEIS
  AND THE PHYSICAL DESTRUCTION OF OUR HISTORIC COMMUNITIES,
  AND I BELIEVE THAT THE RELOCATION AND INTERNMENT IS A
  SUBSTANTIAL CAUSE.
- JAPANESE AMERICANS LOST LAND AND PROPERTY, FREEDOM AND PRIVACY, EDUCATIONAL AND JOB OPPORTUNITIES, DIGNITY AND PRIDE. FOR ALL THIS, THERE IS NO PRICE TAG.
- BUT THE LITTLE TOKYO SERVICE CENTER, LAST APRIL, ENDORSED

  THE EFFORTS OF THE NATIONAL COALITION FOR REDRESS/REPARA-

PECTIVES OF THE COALITION, AND SUPPORT THE JAPANESE COM-MUNITY'S DEMAND FOR JUSTICE NOW, REPARATIONS NOW.
