OPERATING A MOTOR VEHICLE AFTER LICENSE HAS BEEN SUSPENDED IS PUNISHABLE BY IMPRISONMENT IN THE COUNTY JAIL FOR NOT LESS THAN FIVE DAYS NOR MORE THAN SIX MONTHS OR BY FINE OF NOT LESS THAN FIFTY DOLLARS NOR MORE THAN FIVE HUNDRED DOLLARS OR BY BOTH. FAILURE TO APPEAR ALSO CONSTITUTES A SEPARATE VIOLATION FOR WHICH YOU MAY BE PENALIZED REGARDLESS OF THE ORIGINAL CHARGE.
