Claims Alameda County residence since 1926; State since 1918. Mr. Iwamoto was out of the county from June 1941 to December 30, 1941. During that time, he was employed in Stockton and San Francisco. From 1932 to October 1940, he lived at 4564 East 14 Street, Oakland. This is verified throught the city directory from 1937 to 1940 inclusive. October 1940 he moved to 1650 East 6 Avenue, Oakland. He lived there until June 1941 then left the county. During these eight months, he lived with Mr. Akagi, for whom he was employed as an assistant gardener.
