- 1. In 6H we wish to house people who are under periodic medical treatment from the hospital. We also wish to house people who are working at the hospital in 6H, such as: doctors, and nurses aides. Naturally, this means we must house their respective families in this block. At this time this block is full, and shortly we must determine the legitimate cases upon verification from the hospital. This entails a quartering problem; as a family becomes well, and no longer requires periodic attention, they must be expected to move elsewhere(if vacancies are available) to make room for other legitimate cases. This is the present policy only, and is subject to change at any time.
- 2. The above paragraph applies to Block 56, in so far as we need space for medical staff and cases of attention only. Otherwise, there we should like to have the administrative personnel housed, insofar as practicable.
- 3. No one could live SE. All partitions are being removed in the buildings there and that block will become a school.
- 4. The answer to this is the same as answer to Question #1. No steps are contemplated at this time to evacuate anyone in 6H, not at least until all people are here.
- 5. 6F will be opened when the Army makes its decision to release the block.
- 6. Every person wishing to move should submit a request in Block 6F-5-B
- 7. All persons who submit a request should always be given prior consideration.
- 8. Every case is an individual case. We are dealing with people, and people are unpredictable. In cases requiring further clarification it is well for the family to see the person in charge of approving changes. It has often happened that vital information not given on the request form has changed the complexion of their case. This does not mean that people who come to the housing office are taken care of first, because they do have their requests in at the time. There is as great a change to quarter a family more satisfactorily if he is patient for several days, because in the course of time as requests to move are approved combinations and vacancies become available. A disapproval today is not final, since that disapproval might become an approval tomorrow, if tomorrow a vacancy becomes available.
- 9. In considering giving a family of 7 two apartments we must consider the size of apartments available. Families of 7 are living in 2 apartments, but in all ways of moral persuasion we must discourage the practice. At this time it is impossible for us to judge how much room we will still need.
- 16. This has been my attitude toward persons who move first, and apply later. If their justification is more more sound than any written request for that same apartment we have allowed them to remain. When their justification is not as good, we are asking them to return to their former apartment. We must censure and reprimand cases moving without prior

approval, and henceforth we will ask all people who move without approval to move back to their former apartment. If their apartment is occupied without our prior approval this becomes a matter between the two families.

11. We will not allow a group of very young boys to separate and establish bachelor quarters.
