Domman's ordered wuite a few things and a huge order of cocktail picks for all their stores, including Arizona. So to date, this was their largest orderover 100 doz. picks alone. So they are at last ordering sensibly. It seems Miss Glaze has more authority to buy now and is buyer for all the stores. Weve been having a heat wave here too, 88 degrees with smog yesterday and that's really really hot for San Francisco. Julia is helping at the store. Her first class starts tomorrow, and as I take it, she will only be going about once a week. I guess Pinky took her shopping Saturday for some things. Henri is trying to persuade her to lose weight. I hope she does because she can get nicer clothes that way. Henri said you shouldn't have given Kyoto Bito cash because he has enough L/C and Henri gave him cash this spring but he didn't ship any sooner knexxxxxxx in spite of it. Be sure that all shipments to the US has a "japan" label on it. It is so much trouble and costs us money to get the customs inspector over to check the stamping to pass the merchandise. They charge so much an hour. The small desk ca endars cost us two days of labor for us and an hour of inspection just because they didn't put on the "Japan" label on two shipments. They should know better by now. This goes for all items, because it could happen to any and all. So far the worst offenders have been the calendars and Kyoto Bito. The latter is very sloppy on description, packing (not telling us how many per small box, how many, size, pattern, etc., per carton, etc. On your retail purchases as well as wholesale, be sure to specify that they should be pa packed in heavy export cardboard cartons and not wooden cases. The only thing we get in wooden cases and want them that way are the lacquer cigarette lighters due to possibility of pilferage at the pier. Re tassels, we don't understand his argument or rather his excuse because he hasn't shipped even 30-40 pieces in fact he hasn't shipped any to us early June. He should have sent us partial shipment at least. If he had, we could have sold more. Our latest order for tassels call for 170 pieces, which we want partial at least once a month. What you say he said regarding the production of tassels, it sounds so contradictory, it sounds as if he can't or doesn't want to make it at all, or fishing to raise the price.

Por your information, Henri is today ordering bankers' coats and coolie chats for which we have a confirmed order from Gump's so we must have the merchandise by early November here because they want to put in in their Christmas catalog. They want

S,M,L, sixes in 6 dissferent colors, which they specified.

They, Gump's, ordered \$3498.00 worth of garments altogether. Will write more in detail tomorrow. The only worry is, how soon can Kamei ship? They are so agonizingly slow on some things, would it also be true on raw silk garments? Can they handle it? We must have it shipped in about a month or six weeks. They still have other garments on order now besides these new things for which they haven't got the order yet.

Charles Richards wants samples of hichimi (must be course ground) and sansho and a liquid sauce, green in colorfor flavoring such things as yakitori and other things. He also wants good recipe for yakitori if you get a chance.

Eiichi's car got bashed in by a drunk last night while parked. He wasn't in it. Eliz. Hannah says hello. She had baby boy and is working at home. She got your card. So busy here, not enough time and feel desperately rushed. We hope we can out the orders. The month long strike may end tomorrow (truck strike). Hope so. The cube matches selling well. The lac. salt/pepper doing ok too. The candles in glass being way back-ordered. The foil coasters and triple starbursts also. We hope we get the kimono dolls for wholesale real soon. We also are back-

2. Glad you are enjpying your stay. We have to read and re-read your letters because it has so much. Please try and use heavier paper and write on both sides because that Japanese kleenex is so hard to read. It's hard to file too. Henri asks you to write on heavier paper.

Re: Kagawa Ken, the order for teak puzzles still stands and we want them. We are

out and are back-ordering them.

Have to go home now-it's late as usual. Remember when Henri was in Japan? Same thing, can't write letters during the day, have to do it after everyone has gone home.

The hyakuman-ryo banks are all no good- tell Kato- although I think we already

told him. 100% returns. Keys are rusty too.

The Tsunoda cube trick banks with animal designs also coming back-won't open so must be using green limber and not made loose enough to allow for it. No more re-orders unless they can make them right. Oh so many headaches!

Hope the lacquer lighter makers can keep shipping. We are taking care of the 16's as soon as we can and please don't disrupt our schedule here, says Henri,

and he said he warned you before you left. Ignore what shippers say. Got confirmation from Nisho re: you purchase of Zoori, dolls, etc. today and will send money.

Don't worry about Conover and Kaneshima because Henri is giving up Kaneshima.

Both are in very pitiful condition and can't hurt is this year. Henri is so dissatisfied with Kyoto Bito's shipping and documentation, so amateurish. We should work with those we like and have been efficient such as Nizshi.
