We have a number of May 1st orders piled up now.

Pacific Felt people are still on strike. It sure is hard to get cotton. They got it for us last time from Los Angeles, but took quite awhile. We are still trying to catch up on the zabuton orders but only behind about three days now. We hope to get caught up before the cotton runs out again.

Had dinner in chinatown with Warren and his wife. It was nice that Pinkie and Norman came too as well as Pinkie's Chinese friend. Hime and Eiichi joined us later at our house. Warren was so disappointed that you weren't here. We all thought his wife wasn't what we expected him to marry somehow. She is rather aggressive and not a bit pretty. I hear she was a scientist too. They like victorian furniture too. They collect antiques or something.

Got a request for plain pencils with erasers at end without any printing from an imprinting firm. They may be small time, but as we do have samples of exactly the kinfi they want, I replied that minimum order was 100 gross, I case, require L/C or Bank draft. Price in Japan is 77¢ per gross as per sample we have from Kato. Jim figueses \$1.50 landed. Can we quote \$2.50/gross by case or should we say \$3.00? Or don't you want to be bothered? I feel it may be worth it if we start the import

such large quantities.

How did the match business go? Were you able to order them?

We still have a few requests for steak knives but they were a big headache, weren't

orders. It isn't anything that would be so bothersome, that is if they can order

they?

Let us know what you have ordered and how firm the orders are. No samples yet from anyone since woundard we last wrote. I don't think the lighters are too good an idea, the samples that arrived a couple of weeks ago, that is. They seem to have so much trouble making what we already have on order as it is without adding more. We are still not completely stocked on the lighters. #4 in black and white are nearly gone again. #2 in black and white are gone too. We still have lots of #1 and #5, except mustard and pink which they didn't include in the last shipment.

We are very low on the G-10 lacquer fans. We have only three colors in stock. No

purple or green left. Hope they ship soon.

Please write. Is your leg just the same? Hoe much longer in Tokyo? Sat. receipts: \$1,192.56; Today, Mon., \$1,638.70 (wholesale) Not Bad. Curley comes with Tami every afternoon. She is getting back her fur. Will write again. Martha

K. Kato wants about \$3,000 to \$5,000 more in L/C for early May shipments. He has one shipment via President Hoover ear-marked for the latter part of this month which comes to about \$1,500 including your purchases from Ohmiya (kitchen ware, miscellaneous).

Also advised us that he is collecting the samples for you and that he will ship those you are interested in. He expects your return to Tokyo on or about

the 25th of this month.
