And forget Kansai area from now on because I am running out of time, and I will be unable to contact anyone there while I'm in Tokyo. Better you write from USA. And don't forget, I am just one person with just so many hours in a day. I can only do a few things at a time, and it takes time if I have to spend the time looking for a few lousy retail items and taking up so much of my valuable time on wild goose chases. For my retail purchases comes second to my wholesale, I do believe, and I can't be traipsing all over the city looking for a little this and a tittle that and how much business is it altogether? So I would like you to evaluate your requests and I will try to sandwich in your requests when I have time and if I am close to such sources of supply. The pace of the people is so lethargical that one gets quite irritated. And the samples are not ac ording to my requests because so many people are in between that it is really discouraging and heartbreaking. Now that I am getting better, I am raring to to and I do believe that my Kansai trek will be more pleasant and therefore more successful. The last time I had my drippy thigh on my mind constantly and could not concentrate too well on business, and had to return to the Hotel many times for bathing the leg and thus cutting short my buying excursion. I can now do a more concentrated effort.

I decided to go to Nagoya and give John Motoyoshi one more trial and I got a reply to my wire sent him and he will be with me so I shall go to Nagoya first instead of Moji, then to Kyoto and on to Kobe and then finally to Moji. I will still return to Hotel Tokyo on May 19th. I have tentatively reserved my flight back to SF on May 31st. There are no other seats available before that date unless it is May 20th. I have put in a request to fill in any vacancy on flights leaving on the 29th or 30th. I feel that I can accomplish quite a bit during my final week in Japan to clean up loose ends.
