1) Dai-Ichi - Re Y/#3 and 4 Confirmation of your purchase of linen napkins.

Y/#3 - Natural 240 dz, aqua 180 dz, and gold 180 dz, total 600 dz.

Y/#4 - Total - 2,000 dz, colors to be specified later.

Advised us that they are working on new types of napkins, table cloth, and kitchen aprons made of the same type of material, etc. They want a sample (working model) sent from here to copy.

The material for the 2,000 dz of napkins is being weaved already (it might take

2 to 3 months to complete it). They will have the samples, etc., ready for you to see by the time you return from your trip down south.

- 2) Kyoto Bito S/D on Alaska Bear (70 pcs of DRT and 100 sets of YS sparrows) and notice on shipment of the penmanship sets already arranged to make boat sailing from Kobe, April 17th.

 Advised us in reply to our inquiry that it takes anywhere from 20 to 30 days to get the rayon braid w/tassels ready for shipment after receipt of order. Also confirmed our latest P/O for DRT (20 pcs of olive and 10 pcs of white) which will be shipped mid/May.

 Reports meeting you April 14th and that a full report on the proceedings will be made soon.

K. Kato wants about \$3,000 to \$5,000 more in L/C for early May shipments. He has one shipment via President Hoover ear-marked for the latter part of this month which comes to about \$1,500 including your purchases from Ohmiya (kitchen ware, miscellaneous).

Also advised us that he is collecting the samples for you and that he will ship those you are interested in. He expects your return to Tokyo on or about the 25th of this month.
