I have received a letter dated January 28, 1959 from my cousin, Tomoye Takahashi requesting that I deliver to you certain papers and records of the Takahashi Trading Company.

With this letter I hand to you the office files, memoranda and property detailed on the attached list. This constitutes everything referred to in Mrs. Takahashi's letter of January 28 or otherwise relating to the Takahashi Trading Company of which I have possession in the United States.

I have various personal belongings of my own in storage in Japan and it is possible, although improbable, that I have other papers, documents or property belonging to the Takahashi Trading Company among such personal belongings of my own. As you know, I am going to Japan soon for about two months and I shall go through everything I have in storage there to see whether there is any property there belonging to Takahashi Trading Company. If I find anything belonging to or pertaining to Takahashi Trading Company among my effects in Japan, I shall deliver them to you upon my return to San Francisco.

In her said letter of January 28, 1959, Mrs. Takahashi made demand upon me for the sum of \$156.00. This demand I reject because I owe her neither that sum nor any other sum of money.

Mrs. Takahashi also referred in said letter of January 28 to a withdrawal seal for the Takahashi Trading Company bank account with the Sumitomo Bank of Marunouchi, Tokyo. As Takahashi Trading Company's agent, I formerly had that seal in Japan. I cannot find it and do not have it in this country. If I am unable to find it among my effects in Japan, I shall endeavor to make arrangements with that bank while I am in Japan to have a new seal issued to the Takahashi Trading Company and to have such new seal delivered to you.
